I will keep the focus of my article on Legislation and let others address some of the other issues of concern to our members. But if you have questions or concerns not addressed in the Unity, give us a call.

RDPFFA Legislation to grant Pension Tax relief to some Detroit Police and Fire Retirees born after 1952 passes the legislature and is signed into Law by Governor Snyder.

On November 2, 2017 Governor Snyder signed into Law House Bill 4396, which is now Public Act 149 of 2017. We want to thank Representative Joe Bellino (R-Monroe) for sponsoring this legislation and working diligently on behalf of retirees. We would also like to thank Senator Ken Horn (R-Frankenmuth) who sponsored similar legislation and has been a champion for RDPFFA members in the State Senate.

This is an important piece of legislation for Police and Fire retirees who retired from municipalities that did not participate in the Federal Social Security program.

In summary, this legislation will give individuals born after 1952 and retired as of January 1st, 2013 the following tax deduction:

- Individuals filing as a single will receive a \$35,000 deduction
- Individuals filing jointly will receive a \$55,000 deduction


• If both filers retired from a department that did not participate in Social Security, they will receive a \$70,000 deduction

This legislation ensures equal treatment with retirees born after 1952 (and retired as Jan 1, 2013) as those born between 1945 and 1952. The RDPFFA estimates that approximately 750 members of the RDPFFA and 800 non-members will benefit from this legislation.

The RDPFFA has been very successful in its legislative efforts. But; these successes do not come without a cost, and as you see above our legislation endeavors benefit both members and non-members. Yet the total cost of the Association's Legislative efforts is on the backs of our members. The following recap of the Legislation that we pursued and were successful in getting passed over the past several years.

- 1. 2011, House Bill 4135, Public Act 25 of 2011 (Sponsor Rep Fred Durhal) amended State Law to require Pension Board to comply with City Charter and seat Retiree. The RDPFFA had pursued efforts to have a retiree seated on Pension Board for years through many different means including the courts without success.
- 2. 2012, House Bill 5192, Public Act 12 of 2012 (Sponsor Rep Fred Durhal) clarified and strengthened language in House Bill 4135 Public Act 25 of 2011, to force the Pension Board to comply with intent of Law, (Pension Board was refusing to comply with Public Act 25 of 2011)
- 3. 2012, Senate Bill 1189, Public Act 492 of 2012 (Sponsor Senator Mark Jansen) requires equal treatment of retiree on Pension Boards (if Active Trustees are compensated or carry them working, must compensate retiree)

Greetings all, I hope everyone enjoyed this past summer and for those in the area, the great weather we had the past two months. Well we all know that the annual medical open enrolment is here again and the main thing to remember is, if you do not wish to make any changes in your present coverages you do not have to do anything, the plan or plans you have now will continue through 2018. Should you need to make any additions or changes to your plan or plans this is your time to do so, read the packet thoroughly and submit your changes by the deadline.

Another issue that many retirees should become aware of is the Pension System is going to implement a PAYCARD system for the distribution of monthly pension checks. The exact time frame is still being worked on but rest assured it will become a thing of the future. Many may ask what is a PAYCARD and how will it

work? Keep in mind that this will only affect those that still received their pension checks by mail, what will happen is they will be issued a PAYCARD which is like a credit card or debit card and each month their pension payment will be loaded onto the PAYCARD and the retiree will have to use a ATM machine, go to a bank and draw from their PAYCARD or use as a credit or debit card to make purchases or pay your bills. According to the Pension System data approximately 2000 retirees and beneficiaries still receive a paper check. If this is something that may not interest you the easiest way around the PAYCARD system is to have your monthly pension check direct deposited into your bank or credit union. Direct deposit is a safe secure and reliable process once set up, should the first of the month be on a weekend or holiday the deposit is made the Friday or the day before. The direct deposit form can be found on the Pension Systems web site, www.rscd.org or stop by the office and pick one up. I try not to make recommendations to retirees concerning finance or medical decisions but I make an exception on the direct deposit issue, this is something you should think about very seriously. On the other hand you can always put the PAYCARD under the mattress, but really think about it because it is coming.

The first west side membership meeting took place at the old location, Monaghan K of C in October and it was good to get back to the old place, although the attendance was still down there were more members there that the last west side meeting. Just a reminder that the meetings will continue on the first Thursday of each month alternating east side and west side from now until May. Final arrangements have been made for the annual picnic and June meeting in Frankenmuth for 2018. The picnic will take place on Monday June 25, 2018 with the meeting the following morning, Tuesday June 26, 2018. I know it's still a few months away but

Last quarter in the "Unity" issue #130 it was decided to list all non-members names. The first page was titled "RETIREE ROSTER UPDATE". In it we published a list of Fire and Police retirees who currently are non-members of the Association. We would like to make certain that our records are up to date for notification purposes. If your name is on this list, please contact the Association office so that we can verify that your information is current. This was previously done in the July 2012, issue #110. The membership is dwindling and new membership remains just about non-existent, approximately twenty five annually. Consequently, the Board of Directors decided to list non-members.

On many occasions Officers of the Association and Board Members are asked what is our membership number and/or how many retired officers, fire and police are non-members. Notices and requests to join are sent to all non-members. The Association is trying to do everything possible to encourage non-members to join.

All police and fire retired members receive and enjoy benefits that the Retired Detroit Police and Fire Fighters Association have protected or received. A partial list of some of the Association accomplishments was posted in a previous issue, winter 2017, #128. The lengthy lists of benefits achieved (eighteen) date back to 1975 through 2016. The Association continuously has a watchful eye on any potential takeaways of earned benefits. In addition, the Retired Detroit Police Fire Fighters Association provides a number of regular services to members such as: a staffed office 5 days a week to assist retirees and their families, regular General Membership monthly meetings alternating east and west side locations where members are informed of events and their benefits, free use of medical equip-

ment, free use of a Notary service, quarterly "Unity" magazine and Representatives to act on your behalf on Local, State and Federal issues.

After thoughtful discussions the Board decided to post non-members' names. Some (very few) did not like this approach, although we believe our intent is not to embarrass anyone but to make them aware of the benefits for such a small price.

Membership cost is \$3.00 per month \$36.00 annually. The Association's portfolio is managed professionally and the portfolio, assets and investments are doing well. To tell the truth, the addition of new members will increase the group numbers and the additional income will not hurt. The Association would like to appeal to the over 1,000 non-members to join. If any member has any constructive ideas to get new members to join, please call, write, e-mail or stop by the office.



- 4. 2012, Senate Bill 409, Public Act 597 of 2012, (Sponsor Senator Hansen) amends Pension Tax Law to allow for deductions of State Pension Tax for Police and Fire retirees that retired from municipalities that did not participate in the Federal Social Security System. (Note this allows for same deductions given under our most recent legislation House Bill 4396 Public Act 149 of 2017).
- 5. 2013, The RDPFFA used its relationship with the legislators to get the Federal Court to allow the RDPFFA to represent retirees in the Detroit Bankruptcy. A number of the Legislators including those in Leadership positions contacted the Court on behalf of the RDPFFA to be the representatives of Detroit Police and Fire Retirees.
- 6. 2016, House Bill 5421, Public Act 557 of 2016 (Sponsor Rep Laura Cox) VEBA Governance Policy, requires VEBA comply with Open Meetings Act, make annual Financial report available to beneficiaries, and clarifies the RDPFFAs right to remove Trustees they appoint with or without cause.

Every issue that the RDPFFA has engaged on has resulted in a bill being passed and signed into law. Those legislative successes are due in large part to our membership and engagement on issues. If you know any non-members I ask that you point out the importance of joining and assisting the Association. We don't expect everyone to agree totally with everything the Association does. But overall every Retired Detroit Police Officer and Fire Fighter is currently benefiting financially from the recent actions of the RDPFFA, and the benefits they are receiving far exceed the amount of the Association annual dues.

But as pointed out, there is a significant cost associated with these legislative pursuits. The only means available to us to preserve and protect what benefits we still have is through legislation or the courts, and both will require additional financial assistance from our membership. Again I must ask for those that have the ability and resources to donate to the Association to continue to do so.

Under our current dues structure, our total annual income from dues is less than \$200,000 per year. As you know we cannot use General Funds for Political purposes, so we must have a separate fund which maintains the necessary financial resources that allows us to continue our legislative efforts. We ask for your support!!

DEATH OF MEMBER FAMILY ASSISTANCE PROCEDURE

Communications vary whether member was Police, Fire, or Sergeant and above. If you are Police make your first call to the Detroit Police Benefit & Protective Association, (313) 870-9301. Followed by either a call to the Detroit Police Officer Association, (313) 567-8770, or the Lieutenants & Sergeants (313) 961-5699, which ever applies.

While the Detroit Police Benefit & Protective Association will normally contact the City of Detroit with the information it would be reasonable to follow up with a call to the Pension Bureau, (313) 224-3362 Ext. 221 or 1 (800) 339-8344 and Automated Benefit Services (ABS) 1 (800) 645-9978 to make sure that they were notified. Last but not least, notify the Retired Detroit Police & Fire Fighters Association, (586) 795-1734.

Fire employees, start by notifying the Detroit Fire Fighter Association, (313) 962-7546, the Detroit Firemen's Fund Association, (313) 628-0099, Detroit Fire Mutual Fund, (313) 962-4595, and the Detroit Pension Bureau, (313) 224-3362 or 1 (800) 339-8344.

The above agencies will assist you with the notification process. It would be a good idea to put this information with your secured legal documents or some other obvious place where your survivors can locate it.

A Lesson from Hurricane Harvey: Plan for the Worst, Hope for the Best

We've been touting the idea of a family emergency plan for quite a while in our Small Good ChoicesTM literacy series. But seeing the devastation and calamity in Houston brings forth an important small good choice from the Boy Scouts: be prepared. Here are some important ideas that you can do to protect your family in the event of a disaster, ranging from a power outage to floods to whatever.

- Have a family communication plan. Figure out how you will contact each other, both with electricity and without. Remember, in a disaster, the cell towers may be out, as well as the electricity. There is a good chance the phones will not work.
 - o Have a contact card. FEMA 'Family Emergency Communication Plan' has a great example. It's a card with contact info. Write it with waterproof ink and even consider laminating it. If your younger set balks at the idea of a card, inform them that cellphones don't work once the batteries are dead and the cell towers are out.
 - o Have a backup location. This is a spot where you can meet. So you might say to the family: 'If we can't communicate by cell, meet at the even numbered hours at the NE corner of Woodard and Square Lake Road.'
 - o Have emergency numbers ready, in the house, on your phone and somewhere written down (wallet, car, purse).
- Have a family disaster plan.
 - o Determine the escape route out of your house. Have multiple options.
 - o Fix a meeting place after evacuation.

- o Check safety devices, like ladders, fire extinguishers, smoke detectors, etc. A good memorable check date is the da light saving time changes.
- o Practice.
- Have a 'Go' bag or box. This is a container of the immediate emergency items you may need if you have to leave in a hurry.
 - o 3-day supply of food and water
 - o Utensils
 - o First aid kit
 - o Tools or multi-tool
 - o Flashlight and spare batteries
 - o Solar or hand crank phone charger
 - o Emergency radio
 - o Whistle
 - o Mirror (for signaling)
 - o Maps
 - o Contacts list and contact sheet
 - o Copies of crucial documents, like passport and/or driver's license
 - o Zip lock bags
 - o Pet supplies (3 days food, medications, leash)
 - o Mace or self-defense device
 - o 3 day supply of medications
 - o Contact lenses and spare eyeglasses
 - o Extra set of house and car keys
 - o Child supplies (diapers, formula, bottles)
 - o Some cash: ATMs don't work without electricity, and neither do credit cards
 - o Duct tape

Put all of your stuff in a waterproof bag or a large Tupperware container. Write your name and contact info on the container (waterproof ink). Yes, this sounds a little frightening. Look at the images of the poor folks in Houston or any disaster. Would you rather run out of your house in your pajamas, wondering what was going on, and having your cell phone quit because the water rose above it, or have a plan? Take some time with your family and work out the 'what we will do' scenario. We hope you'll never need it. But plan for the worst and hope for the best.
