

The Retired Detroit Police and Fire Fighters Association prints a publication titled the "Unity" and sends a copy to the membership, approximately 5,200 are distributed. Today we represent everyone in matters concerning pension, hospitalization, and insurance. I frequently make a request to our members and readers to submit suggestions regarding our dwindling membership with ways to move forward with our challenge.

Contained within the quarterly magazine is a prepared "Remembrance and Thank You" list of supporters, who have contributed generously to our Association, many of them are repeat donors who want their loved ones recognized. In addition, a "Members Letters" section is provided for supporters to take the time to jot down their thoughts and send them to us for printing. All supporters' letters and notes are respectably read, the generous donations are appreciated and members who take the time with a note are taken seriously.

I would like to address a number of suggestions submitted, beginning with increasing the annual dues to our Association. Regularly when reporting finances, I recite an accounting of income and expenses; the Association's outflows are always higher than revenue taken in. This short fall is resolved by regularly transferring invested assets to pay for the expenditures.

MEMBERS PLEASE NOTE

For your information and the Associations benefit, it is important that when your summer/winter address changes, we are notified in advance of the move and again when you are returning to your home address. That way we can keep you current. We don't want to lose you in the process.

Logically, the need to increase dues is a sound idea, though, the RDPFFA Officers and Board of Directors have reviewed this issue and determined with the amount of our assets, professionally invested, this is not the time for an increase in dues.

At the Thursday, September 2, 2021, General Membership Meeting, I recognized the substantial donation made by the Cowell Family Trust to our Association. I made a comment in jest for members to consider, although not completely out of the realm of possibility, that circumstances with your portfolio could have similar results placing the RDPFFA as a beneficiary. Earlier this year prior to the Cowell Trust donation, Loren Wagner "Daddy Wags", was forward thinking and investigating a proposal making the Association a recipient of a planned investment. John M. Tsampikou made a number of suggestions: such as expanding membership eligibility, printing an eligibility list and allowing family members to join. Emery Esse sent a written communication to the Association stating that he feels only members should receive the updates. Also, he suggests sending non-members a letter recapping what the Association is doing for all Police and Fire retirees. I have singled out a few members who took the time to suggest proposals and recommendations, I give my sincere appreciation.

A common suggestion is to publish a non-member list. So, to keep our records up to date for notification purposes, the Association will do a Retiree Roster Update, a list of Fire and Police retirees who are currently non-members of the Association. A list was printed in Volume 130, Summer 2017, and Volume 140, Winter 2020. A list will again be published at some point in 2022.

Finally, there are many member ideas that could take pages to publicize but I have listed only a few. Be assured that all thoughts submitted will never be ignored. Your encouragement and support are the driving force that motivates us in the RDPFFA office to continue to represent survivors and beneficiaries as we do.



DEATH OF MEMBER FAMILY ASSISTANCE PROCEDURE

Communications vary whether member was Police, Fire, or Sergeant and above. If you are Police make your first call to the Detroit Police Benefit & Protective Association, (313) 870-9304. Followed by either a call to the Detroit Police Officer Association, (313) 567-8770, or the Lieutenants & Sergeants (313) 961-5699, which ever applies.

While the Detroit Police Benefit & Protective Association will normally contact the City of Detroit with the information it would be reasonable to follow up with a call to the Pension Bureau, (313) 224-3362 Ext. 221 or 1 (800) 339-8344 and BeneSys (833) 725-5336 to make sure that they were notified. Last but not least, notify the Retired Detroit Police & Fire Fighters Association, (586) 795-1734.

Fire employees, start by notifying the Detroit Fire Fighter Association, (313) 962-7546, the Detroit Firemen's Fund Association, (313) 628-0099, Detroit Fire Mutual Fund call Firemen's Fund Association to leave a message, and the Detroit Pension Bureau, (313) 224-3362 or (800) 339-8344, ext 221.

The above agencies will assist you with the notification process. It would be a good idea to put this information with your secured legal documents or some other obvious place where your survivors can locate it.

In Remembrance of Norman Lippitt

Judge Norman Lippitt Died on Monday, July 26, 2021

For 17 years, until 1984, Lippitt was the lead counsel for the Detroit Police Officers Association, defending cops in high-profile cases. Before that, he was a Wayne County assistant prosecutor. His private practice as a criminal lawyer thrived, but then-Governor James Blanchard appointed him to the Oakland County Circuit Court bench in 1985. In 1988 he gave

up his gavel and returned to private practice, where he focused primality on commercial cases. He eventually founded the Birmingham law firm Hyman Lippitt, and later Lippitt O'Keefe in Birmingham.

Charitable Gifts to the RDPFFA

Recently, the RDPFFA received a bequest from a deceased member who wanted to leave a legacy for his fellow brothers and sisters. The bequest helps preserve the Association and allows us to serve our members more fully. We asked Leon LaBrecque, JD, CPA, CFP®, CFA from our advisory firm Sequoia Financial Group, about the financial aspects of making donations to the Association.

Can I make a gift to RDPFFA? Yes, anyone can donate to the RDPFFA. RDPFFA is an IRS-approved §501(c) (4) organization, which means RDPFFA is a tax-free 'social welfare' group.

Are gifts to the RDPFFA tax-deductible? Gifts to a §501(c)(4) are not tax-deductible for income tax purposes. However, making a gift of an asset that has appreciated will remove the capital gains from taxes. For example, if you owned a stock that had gone up in value, you would not pay the income taxes on the capital gains on the stock, The RDPFFA can then sell the stock tax-free and apply the funds to their mission.

Can I leave a bequest to the RDPFFA in my Will or Trust? Yes. You can clearly bequeath assets to the RDPFFA in your Will or Trust. RDPFFA has an attorney who will provide the language for your document or modify your document for a very modest fee.

What kind of assets can I donate to the RDPFFA? Obviously, you can make a cash donation. Gifts and bequests can also include stocks, mutual funds, and ETFs. There are ways to make other assets work as well: crypto currency (for example, bitcoin), real estate (which would be sold) can also be donated. If you are considering a gift of an unconventional property, it's best to contact the RDPFFA staff first. You cannot donate from an IRA to the RDPFFA, but you have many options for leaving a legacy to the RDPFFA. Gifting an appreciated asset during your lifetime benefit you by saving capital gains taxes. Life insurance can also be used to make a donation, you would simply change the beneficiary designation.

If I want to donate, what do I do next? If you'd like to make a cash donation, simply make the check payable to the RDPFFA and send it to the Association directly. If you would like to donate stock or a trades security, let the Association know and they can arrange to transfer the security to a brokerage account. To make a bequest in your Will or Trust, there is simple language that can be added to your documents, but you will need the assistance of an attorney. You have myriad options available to you to create a lasting legacy for the RDPFFA, your gift can create a positive impact in the lives of your brothers and sisters, and the communities they serve.
