PRESIDENT

I want to start by expressing our prayers, concerns and best wishes for all those that may have been affected by the recent hurricane in Florida, especially all our members who live there full or part time, or own property in the affected areas.

Social Security Windfall and Pension offset. For over 50 years we have been waiting for the legislators in Washington to step up and overturn these unjust and unfair portions of Social Security that discriminates against many public safety officers. For the first time it looked as if the House of Representatives were finally going to vote on legislation overturning these portions of Social Security, under House Resolution 82. HR 82 was introduced by Representative Rodney Davis (R-IL) on January 4, 2021 and referred to the Ways and Means Committee, Chaired by Richard Neal (D-MA). Under a relatively new US House rule any legislation which reaches and maintains 290 or more cosponsors for 25 Legislative days, and the committee of jurisdiction does not report the legislation, it will be placed on the House Consensus calendar and would require a vote by the full house. H.R. 82 reached the required 290 cosponsors on July 15, 2022 and a motion was made to place the legislation on the Consensus Calendar. Now the bad news, H.R. 82 was referred to the Ways and Means Committee in January of 2021, and they did not take any action on the legislation until

September 20, 2022 the date the legislation would be moving to the Full House for a vote. The Ways and Means committee met and voted out the Legislation without a recommendation. I watched the Hearing and it was obvious that the only reason they met was to meet the requirement of the Committee of jurisdiction reporting out the legislation. By meeting and voting out the legislation, it was removed from the fast track consensus calendar, which removed the requirement that the House Vote on the legislation. So the bottom line is that the action taken by the Ways and Means Committee, likely killed any chance of this legislation being passed into Law. The current legislative session ends on December 31, 2022, so any legislation not signed into law by that date will expire.

On a little more positive note on the Federal level, "H.R. 3967 Honoring our PACT Act of 2022", was signed into law and gives some additional benefits to those Veterans with diseases associated with exposure to certain herbicide agents which there is now a presumption of service connection for veterans who served in certain locations. This new law includes those that served in Vietnam and suffer from hypertension. If you served in the military you might want to talk to one of the Veteran Organizations to see if you may be entitled to some benefits.

We continue to monitor a number of items of legislation in Lansing that may have some effect on our members. With this being an election year the legislators have not been meeting much in September and October while they are out campaigning. Once the election is over they will return for what is referred to as the lame duck session. This is when they stay for long days and push through as many pieces of legislation as they can. With the divided government in Lansing it is not likely that any controversial legislation will be signed into law.

ees amounts have been activated by the City. So hang in there it will be coming. Remember this is for old plan Police retiree's only the Fire Fighters old plan members did receive their increases on the August checks. We will make every attempt to keep those involved apprised on the progress.

We had the west side meeting this month and I think those that attended enjoyed themselves and the food was great as usual, Benesys was in attendance and answered some individual members questions and concerns, with that being said we all should have received the Open Enrolment Packet for 2023. We ask that everyone open and read the information and if you have any questions give the office a call or if you can attend one of the Open Enrolment Meetings, the locations, dates and times are in the packet.

The next General Meeting will be on the east side and is scheduled for December 1st, 2022 at the Polish Century Club, mark it on those busy calendars and hope to see you there. There will also be meetings in March and May 2023, the March meeting will take place at the Stitt American Legion Post on the west side and the May meeting will again be at the Polish Century Club. Again next year the Annual Picnic and June General Meeting will be in Frankenmuth at the Bavarian Inn with the picnic on Monday, June 26th and the General

Accounts Pins to Accounts, Credit Card Accounts, Tax Returns and Stock Certificates.

Plus, the location of Monetary Assets, Banks, Investment Accounts and Personal Computer Accounts should be recorded. It may seem overwhelming but you must take the time putting the information together for you and your families benefit. In addition, Power of Attorney, Health Care and final funeral, as well as burial family's arrangements are of upmost importance for your beneficiaries.

FAMILY ASSISTANCE PROCEDURE

Communications vary whether the member was Police, Fire, or Sergeant and above. If you are Police, make your first call to the Detroit Police Benefit & Protective Association, (313) 870-9304. Followed by either a call to the Detroit Police Officer Association, (313) 567-8770, or the Lieutenants & Sergeants (313) 961-5699, which ever applies.

While the Detroit Police Benefit & Protective Association will normally contact the City of Detroit with the information, it would be reasonable to follow up with a call to the Pension Bureau, (313) 224-3362 or 1 (800) 339-8344 and BeneSys at (833) 725-5336 to make sure that they were notified. Last but not least, notify the Retired Detroit Police & Fire Fighters Association at (586) 795-1734.

Fire employees, start by notifying the Detroit Fire Fighter Association, (313) 962-7546, the Detroit Firemen's Fund Association and Detroit Fire Mutual Fund, (313) 628-0099, and the Police and Fire Retirement System (PFRS), (313) 224-3362 or 1 (800) 339-8344, extension 221.

The above agencies will assist you with the notification process. It would be a good idea to put this information with your secured legal documents or some other obvious place where your survivors can locate it.

The Significance of the Maltese Cross

From the days of the first crusade, the cross has been the symbol of the Christian warrior who pledged not only to fight in defense of the Holy Land, but also to protect the lives of his compatriots. The Maltese Cross, now worn by modern firefighters, is actually an adaptation of a particular crusader insignia, the cross of the Knights of St. John of Jerusalem.

During the crusades, many Knights became firefighters out of necessity. Their enemies had resorted to throwing bombs and sailing war vessels containing naphtha. Hundreds of Knights were burned alive. Others risked their lives to save their brothers in arms from dying painful fiery deaths. Thus these men became our first firefighters and the first of a long list of courageous firefighters.

The Maltese Cross is your symbol of protection. It means that the firefighter who wears this cross is willing to lay down his/her life for you, just as Crusaders sacrificed their lives for their fellow man so many years ago.

The Maltese Cross is a Firefighter's badge of honor, signifying that he/she works in courage... a ladder-run away from death.
