It's that time of the year; some of us are getting ready for the cold and snow, while others are looking forward to heading south to the warm weather. All are preparing for the holiday session.

As you look forward to the New Year, remember when it's tax time the Michigan Legislatures passed a new pension/retirement income tax bill which went into effect for tax year 2023. House Bill 4001, which is now Public Act 4 of 2023, eliminates all Pension/Retirement tax for police and fire retirees starting with your 2023 retirement income. For all other retirees, there is a four year phase-in and a cap on the amount. Currently the new law has not gone into effect because the legislation was not able to attain enough votes to be given immediate effect. Normally what happens with Bills that were not granted immediate effective, they go into effect 90 days after the current legislative session ends, which normally would have the session ending on December 31, so the Bills would go into effect around April 1, of 2024. There is talk in Lansing that the Democrats may end the current legislative session on Nov 9, 2023 which would give the Bills that were affected an effective date around the first part of February 2024. So it is important that you

wait to file your 2023 Michigan taxes until you are sure that the new pension tax Bill has gone into effect. We will keep you updated. We should know the dates that all the passed Bills will go into effect by our December 7th General meeting. On the Federal level, once again there is legislation to overturn the Social Security Pension off-set and Windfall Act. The Bill H.R. 82 has once again reached the required number of co-sponsors, of 290 (current 296), which would require action by the full house of Representatives. The current House rules are: "US House rule any legislation which reaches and maintains 290 or more cosponsors for 25 Legislative days, and the committee of jurisdiction does not report the legislation, it will be placed on the House Consensus calendar and would require a vote by the full house".

House rules will require action if the Ways and Means Committee takes no action on the Bill. You may recall this was the same situation with similar Federal Legislation in 2022, and all the Ways and Means Committee did was voted on the Bill without a recommendation, which removed the requirement for the full House of Representatives to vote on the Bill. We will continue to monitor HR 82 and keep you updated.

That's it for now. Enjoy the upcoming holiday season, and attend the Association functions when you have time. Since our next Unity Magazine isn't due until January, I'm wishing all of you a Merry Christmas and a Happy New Year now.

Greetings everyone, I hope you all enjoyed the summer months and had great times with family and friends. It has been quiet here on the home front which is probably good news. The Pension System is doing fine although the City is still deciding how they are going to make their annual contribution which is due June 30, 2024. They are waiting on the Bankruptcy Court to make their decision on the amortization question. Once this is decided the City will know the amount they will be required to pay and how they plan on making the payment which could be quarterly, monthly or a lump sum prior to the due date. Once the court makes its decision we will let you know. You may have heard talk or seen coverage of possible changes that may have an impact on retirees, this information included restoring COLA, 13th checks and so on. Remember this is just talk and there is nothing on the table or any serious negotiations going on.

The VEBA for those who retired prior to January 1, 2015 is also doing fine. The annual open enrolment period is over for anyone desiring to make changes to their present health care so if you did make a change it will go into effect on January 1, 2024. If you chose to keep your present coverage no action was necessary and your present coverage will not change. Keep in mind that the last day to request your 2023 HRA is

March 31, 2024. Both the east side and west side open enrolment sessions were well attended and great information was given for the 2024 year. For those members who retired after January 1, 2015 you are also represented by a VEBA and unfortunately the Association can only advise those members to contact their represented Union for any information you may need. For some reason the Board who runs the new VEBA failed to include a retired member on that Board. So if you should have a question or reason to find out what you are entitled to give the Union who represented you a call and it may also be a good idea to ask them why they failed to give a retired member a seat on that VEBA Board. This Association would love to be able to answer any questions or issues but we just do not have the information, so if you are a member of this VEBA give them a call and ask.

The October West Side General Meeting just took place and was well attended, the food was great and the company was the best part. The next General Meeting will take place Thursday December 7, 2023 on the east side @ American Polish Century Club. Get it on those busy calendars and we hope to see you there. Along with the General Meetings the Association will continue the Annual Picnic and June General Meeting in Frankenmuth in 2024. I know it is a ways off but it will be after the winter months (which is fine with me) more information will come as it get closer so keep June 17th (picnic) and June 18th (meeting) in mind.

On July 10, 2023, the Association received the 4th and final benefit in the amount of \$5,400. The RDPFFA received a total of \$396,900 and the generosity of the Cowell family trust is properly appreciated.

Continuing, I am reminding our members not to overlook updating your beneficiaries. Take the time

and put the information together. It is important to list where documents and financial information can be found such as a Will, Trust, Birth Certificate, Marriage Certificate, Original Social Security Card, Insurance Policies, Deeds, Bank Accounts Pins to Accounts, Credit Card Accounts, Tax Returns and Stock Certificates. Coupled with the location of Monetary Assets, Banks, Investment Accounts and Personal Computer Accounts should be recorded.

It may seem overwhelming but you must take the time putting the information together for you and your family’s benefit. In addition, Power of Attorney, Health Care and final wishes, concerning burial and funeral arrangements are of upmost importance for your beneficiaries.

Please do not put off this undertaking, contact your attorney or if you do not know where to go, contact one of the estate planners who support the RDPFFA with an ad in the Unity. Listed below are advertisers who place an ad in the Unity.

In conclusion, Taxable Income HB No. 4001, Public Act No. 4 Public Acts of 2023 allows for one hundred percent reduction for retirement or pension benefits received for services as a public police or fire department employee for tax years beginning on and after January 1, 2023. (SEE - President Taylor’s column for more detailed information).

DEATH OF MEMBER

FAMILY ASSISTANCE PROCEDURE

Communications vary whether member was Police, Fire, or Sergeant and above. If you are Police make your first call to the Detroit Police Benefit & Protective Association, (313) 870-9304. Followed by either a call to the Detroit Police Officer Association, (313) 567-8770, or the Lieutenants & Sergeants (313) 961-5699, which ever applies.

While the Detroit Police Benefit & Protective Association will normally contact the City of Detroit with the information it would be reasonable to follow up with a call to the Pension Bureau, (313) 224-3362 Ext. 221 or 1 (800) 339-8344 and BeneSys (833) 725-5336 to make sure that they were notified. Last but not least, notify the Retired Detroit Police & Fire Fighters Association, (586) 795-1734.

Fire employees, start by notifying the Detroit Fire Fighter Association, (313) 962-7546, the Detroit Firemen’s Fund Association, (313) 628-0099, Detroit Fire Mutual Fund call Firemen’s Fund Association to leave a message, and the Detroit Pension Bureau, (313) 224-3362 or (800) 339-8344, ext 221.

The above agencies will assist you with the notification process. It would be a good idea to put this information with your secured legal documents or some other obvious place where your survivors can locate it.

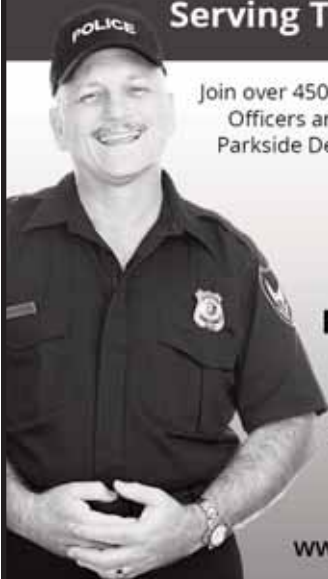

Retirees born between 1946 and 1952 are entitled to an increased deduction on their Michigan Tax Return. This could result in additional \$650.00 per year.

Also, Retirees born after 1952 and retired before January 1, 2013 are entitled to a deduction on their State of Michigan return which may result in up to \$2,000.00 per year.

Michigan allows you to amend tax returns for 4 years.
