

Spring has arrived and we are still living with the Virus, but it appears that, many of our members are in the age group that has been vaccinated, so the association is looking forward to starting to return to a somewhat normal operation. We have scheduled the Golf outing and the picnic in Frankenmuth. Currently those two events are all that have been scheduled. There are still restrictions in place that we must comply with, and the safety of our membership comes first. Hopefully within the next few months everyone will be vaccinated and we will see an end to the coronavirus.

Not related to covid, the Association membership continues to shrink. At our peak, the membership was just below 7 thousand. Today we are just above 5 thousand. No one retires from Detroit any more, as you know, the active membership of both Police & Fire has been cut in half. The new retirees do not receive any Healthcare benefits, so they can't afford to retire, unless they have another job that provides healthcare coverage. On average, from natural causes, we lose approximately 30 members a month and gain one or two new members. If you run into anyone that is a retiree and

not a member ask them to do their part and join the Association. The Association continues its efforts to protect all retirees benefits, this includes the benefits of non-members, so everyone should do their part.

With the start of 2021, On the Federal level there is a new Senate and House of Representatives and they are discussing lowering the Medicare age. I have sent communications to both Senators Stabenow and Peters regarding this issue. On April 21, 2021 Senator Stabenow introduced new legislation that would lower the age for Medicare to 50. With the loss of healthcare for Detroit Police and Fire retirees, the lowering of the Medicare age could be a major benefit for some current and future Detroit retirees affording them the opportunity to lower their healthcare costs.

On the State level, there have been a number of pieces of legislation that could affect our membership. Legislation to repeal the pension tax has been intro-

Should these restrictions change for the better we will make every attempt to have the breakfast meeting. Now the really bad news, this means that we will be unable to have the world famous hospitality room. I know this will disappoint many but please don't let that determine whether you attend the picnic or not. To make your reservations at the Bavarian Inn give them a call at (989) 652-7200 and give them our booking number 1365RV. The price for the room remained the same as prior picnics, \$109.00 per night. More information will be made available should anything change. Hope to see many of you there.

On the pension side of things I have a few updates on prior issues. As was mentioned several months ago, those that still receive a paper check through the U.S. Postal Service have been notified that effective with the May 2021 pension check you will no longer be receiving the paper check. You will be required to either have direct deposit or chose the money be deposited in a debit type card. According to the staff the response was very good with the majority of retirees making their choice and they should not have a problem. Those that have not responded will be required to go to the Pension System to pick up the May check and make their deposit choice. As far as the mailing of the monthly pension pay stub, that will continue for a few more months. Arrangements are being made for those retirees who do not have access to a computer and still would like a monthly stub to pay a small minimal fee for the mailing of the stub every month. The time frame and amount is still being determined. Retirees can still get registered in the new Pension System Retiree Personal Portal which will allow the member to access quite a bit of information that is included in your file. Data includes information from the time of hire to pre-



This past year has been quite the experience, interesting, along with perplexing times, as Coronavirus Disease 2019 began spreading in Wuhan, China, it became an epidemic. 






The American Rescue Plan Is Here: More Stimulus

As we crest the one-year mark of the onset of COVID-19, Congress has passed an additional relief package in the form of the American Rescue Plan (ARPAA) Act of 2021. The ARPAA is scheduled to be signed into law by President Biden before the enhanced unemployment benefits previously extended by the Consolidated Appropriations Act, 2021 (CCA) expire on March 14. This legislation contains several key provisions that could impact your personal and business tax and financial planning.

Another round of direct payments will be sent to taxpayers with Adjusted Gross Income (AGI) less than \$75,000 for single filers and \$150,000 for joint filers. The maximum payment is \$1,400 per adult and qualifying dependent, bringing total potential payments to \$2,000 per person when combined with the \$600 payments that were made under the CCA. The ARPAA expands the definition of qualifying dependents for whom taxpayers are eligible to receive payments. Taxpayers previously only received payments for dependents age 16 and under. The expanded definition now includes children who are either under the age 19 at the end of the tax year, full-time students under the age of 24 at the end of the year, or permanently and totally disabled at any time during the year, as well as qualifying relatives such as aging parents that a taxpayer might be supporting. Compared to income phaseout thresholds for payments made under the CCA and Coronavirus Aid, Relief, & Economic Security (CARES) Act, the AGI phaseout thresholds under the ARPA are lower, meaning that payments taper off faster (see the graph below). If you'll be receiving this additional stimulus payment and are considering options for how to use the funds, review our suggestions as outlined in our prior communication discussing the original stimulus payments authorized by the CARES Act.

The ARPA also temporarily expands the child tax credit for 2021 to a fully refundable \$3,600 for children age five or younger and \$3,000 for children ages six to 17, with phaseouts beginning when AGI reaches \$75,000 for single filers and \$150,000 for joint filers. In addition to increasing the dollar amount of the credit, the expanded credit is fully refundable, compared to the standard child tax credit of which up to \$1,400 could be refundable and which requires at least \$2,500 of earned income. The expanded credit also covers 17-year-old children rather than stopping after age 16. The IRS plans to periodically advance the credit to qualifying taxpayers, meaning that monthly payments are likely to hit their bank accounts from July through December 2021, with the rest of the credit claimed when they file their 2021 tax returns. Taxpayers who are phased out of the expanded credit may still claim the regular child tax credit of \$2,000 per child subject to AGI thresholds of \$200,000 for single filers and \$400,000 for joint filers.

With federal unemployment benefits about to expire, the ARPA does extend those payments of \$300 per week through September 6. It also waives federal taxes on the first \$10,200 of unemployment benefits collected in 2020 (\$20,400 for joint filers) subject to AGI limits of \$150,000. Some states do tax unemployment benefits, and they may not waive the tax to align with this new federal provision.

On the student loan front, the ARPA provides tax-free treatment to taxpayers who have student loans discharged through 2025. Absent this provision, debt cancellation is usually treated as taxable income.

From a business standpoint, the ARPA provides additional funds for the Paycheck Protection Program (PPP) and Economic Injury Disaster Loan (EIDL) Advance Grants Program, among other grants. It also extends the Employee Retention Credit (ERC). Some of these provisions are interrelated, so we recommend consulting your tax advisor to determine the optimal tax strategy for your business. Notably, proposals to increase the minimum wage were not included in the final legislation.
