## PRESIDENT

It looks like we made it through another Michigan winter, this one wasn't bad. We only had to shovel snow a couple times and the temperatures were fairly mild. It now time to start thinking about the Association summer events. The Association General Meeting and Picnic in Frankenmuth will be June 17 & 18. The Golf Outing is scheduled for August 9th at Oakridge Golf Course.

There's nothing new happening with the legislatures in Lansing, however the Association is currently involved in possible Lawsuit against some members of State Government for what we believe was improper distributions of Grant Funds from the State Budget. We became aware of proposed funds for Retiree "Voluntary Employees Beneficiary Association" better known as VEBAs in the State Budget. We reviewed the language being proposed and were sure the language would cover the VEBA that all of our members that retired prior to January 1, 2015 belonged to. Once the legislators approved the budget and the Governor signed it into Law, the VEBA Board sent a letter to the State regarding these funds, and as far as I know they didn't even receive a response. It is now our under-

standing that these funds were distributed to VEBAs formed after the Detroit Bankruptcy. Below is a copy of the actual language from the Law that was passed, Public Act 119 of 2023 Article 9, Section 1010(8):

**(8) From the funds appropriated in part 1 for healthcare grants, \$10,000,000.00 must be awarded to a voluntary employee's beneficiary association located in a city with a population greater than 600,000 according to the most recent federal decennial census that was formed during the city's bankruptcy. The funds shall be used to provide association members funding for benefits that were reduced because of the city's bankruptcy.**

We will keep you updated regarding this matter and notify you if and when the lawsuit is filed.

Regarding Federal Legislation once again legislation has been filed regarding Social Security Windfall and Pension Offset. H.R. 82 Social Security Fairness Act of 2023, Sponsor is Representative Garrel Graves (R-LA) and has 311 current co-sponsors, which is once again enough to require action by the committee, House Committee on Ways and Means, or if no action by the Committee it would require action by the full House of Representatives. As you may recall in the last legislative session there was enough co-sponsors to require action, and what the committee did was voted the Bill out of Committee "Without Recommendation" which removed the requirement for the full House to take action. So this could be the same action they take this time. But we will continue you to monitor just in case by some miracle, they do actually move the Bill.

Greetings everyone, I hope all is well with all of you and you survived the winter and are getting ready for the spring and summer months. The past few months have been quiet which is a probably a good thing. The pension system is doing fine so those checks will continue into the future. The City is required to make their annual contribution to the system by June 30th but it appears that they are waiting for a ruling from the bankruptcy court on the systems appeal of the court's ruling on the amortization period. If the systems appeal is denied the amount will be in the area of 70-75 million and if the appeal is approved the amount will grow another 10-15 million. Either way the City has the money and they are expected to pay by the due date.

Switching over to the Association news, we all know that the Annual Picnic and General Meeting are fast approaching. The dates are June 16 17 and 18; the fun begins on Sunday night the 16th with a hospitality room located in the Bavarian Inn then continues on Monday the 17th with the Annual Picnic located at Heritage Park which is located right behind the Bavarian Inn. After the picnic the Hospitality Room will be open again that evening and then finish up with the Annual Breakfast Meeting the next morning on Tuesday the 18th. Those planning on attending can make reservations by calling the Bavarian Inn @ (989)

652-7200 and using the group number, 1305WA (use the letter O). The nightly rate for the standard room is \$139.00 plus tax and new this year is a resort fee of \$29.99 which according to the Bavarian Inn will allow them to continually make improvements to their guest experience. So it looks like you will have to dig a little deeper under those mattresses for this year's stay. I hope to see many of you there this year because I always look forward to seeing many of you and finding about all the new medical procedures that have been performed over the past year and don't forget to pack all your medications. Also scheduled in the next few months is the Associations Annual Golf Outing which is scheduled for Friday August 9th 2024 there will be more information to come so stay- tuned.

Again I would like to remind everyone that keeping this Association having the ability to continue to serve our members it is imperative to recruit some younger members. If you have relatives, friends or know of recent retirees, remind them of this Association and ask them to consider joining. ## SECRETARY/ TREASURER

The Retired Detroit Police and Fire fighters Association annually has a total of five General Membership Meetings, two on the west side, one in March and one in October at the American Legion Carl E. Stitt located at 23850 Military Rd., Dearborn Heights and two on the east side one in May and one in December at the American Polish Century at 33204 Maple Lane, Sterling Heights. The fifth meeting is in June at the Bavarian Inn located in Frankenmuth, MI. We conduct business at the General Membership Meetings, reporting a roll call of deceased members following with financial matters and updating the membership on legislative actions that could affect our members. A meal and beverages are provided to all in attendance.

The business of the Retired Detroit Police and Fire Fighters Association is constantly being monitored by a Board of Directors. The Board meets at the RDPFFA office located at 2525 E. 14 Mile Road on third Tuesday of every month. On July 18, 2013 the City of Detroit filed for Chapter 9 bankruptcy. It was largest municipal bankruptcy in U.S. history. One of our concerns is

membership and our numbers are steadily declining. When Detroit exited bankruptcy in December 2014, a startling figure from RDPFFA entries of members receiving a pension check on payroll deduction was 4,897. The number currently is 3,739 decreasing our numbers by 1,158, over 24 percent reduction for the last nine years.

Previously, the Association was able to recruit new members in the course of the regular cycle of hires and retirements but things have changed with active members. The members are delaying retirement, waiting for Medicare age because of the lack of healthcare after retirement. Consequently, over the last nine years we have only added 274 to our membership rolls which amount to over 30 each year. The present active Police and Fire department personnel numbers are at 2,500 police and 850 firefighters.

The Association has taken the applicable steps with recruiting by making announcements at General Membership meeting, reminders in the quarterly Unity magazine and requesting our members to assist in recruiting. The Police Personnel Unit assists us by passing out information to retiring members requesting that they join the RDPFFA. The Firemen's Fund goes one step further by providing newly retired personnel with a packet to join the Retirees Association along with payment of the first year's annual dues. We truly appreciate the assistance given by all.

We welcome all and any suggestions from our members to promote our organization and look forward to many more years of providing services and camaraderie for the RDPFFA membership. Moreover the Association is always looking for ideas to organize events for members to come together making it attractive and worthwhile to be a member of the Association.
