I will start by wishing everyone a HAPPY NEW YEAR and I hope that you and your family will have a healthy and prosperous 2018.

I think all of us in Michigan envy the Snow Birds, and all of you that were lucky enough to escape from this deep freeze we're living through. Hopefully we will see some warmer temperatures sometime soon.

The Healthcare open enrollment has come and gone. As always there were a few problems. When dealing with thousands of individuals healthcare contracts there may always be a few that fall through the cracks. But, as one of the Trustees, I can ensure you that the Trustees are monitoring our service providers and if inexcusable errors are found to have been committed by the service providers we will be looking into taking corrective action. If you had problems that you believe were not addressed properly let us know. The Trustees are considering setting up a position within the Trust to assist beneficiaries with their Healthcare problems, dealing with service providers, ensuring you are receiving all the benefits you are entitled to, assisting you during open enrollment, or any problems you may encounter. We will keep you updated regarding this new service that may become available shortly.

On the Legislative front, as you know we were successful in passing legislation in 2017 that granted some tax relief to some of our members, but we still need to

address those that we have not been able to covered under our previous legislation.

Along with our continuing efforts regarding full pension tax relief, we have had some discussions with legislators regarding our healthcare coverage issues. Once the legislators return to work we will be meeting with them to see if we can find a way for us to attain healthcare coverage at a reasonable cost. Our members, that are pre-Medicare age or don't qualify for Medicare, continue to pay outrageous premiums for little coverage. This is a difficult subject, and we will continue to look into all options including both state and federal legislation. If you have any suggestions or are aware of any other Public Safety groups that have Healthcare plans, that if we were able to duplicate, would benefit us let me know.

As we begin a new year, I would like to run through the RDPFFA activities, income and expenses for the year, along with a summary from January 1, 2017 to December 31, 2017.

A direct quote from the Restated Bylaws of the Retired Detroit Police and Fire Fighters Association states, in part, "The purposes of the Association shall be: To provide the Members with information concerning the status of Pensions, Hospitalization and Insurances." The organization achieves pension issue goals by supporting two elected pension representatives' one fire and one police who in return report to the membership all relevant activities. Hospitalization Benefits, are repeatedly monitored by elected Trustees, a majority are RDPFFA Board of Director members who report to the participants all applicable information.

In addition, the Retired Detroit Police and Fire Fighters Association objective is to promote a spirit of good fellowship and a closer personal relationship among members and their families. Attempting to accomplish this goal the Association arranges an annual picnic and coordinates a golf outing as well as a seminar/convention in Las Vegas. The Association is organized and shall be operated exclusively for the purposes set forth in Section 501(c) (4) of the Internal Revenue Code.

This is a summary of year end numbers gathered by the Retired Detroit Police Fire Fighters Association Secretary-Treasurer for vour information. Approximately 5,900 persons were participants in the Association at the end of 2017, of those members, 4,700 are on payroll deduction. Persons not eligible for automatic payroll deduction pay dues annually. To a large extent the 2017 RDPFFA expenses represents twelve categories such as: Donations, General Meetings, Honorariums, Insurance, Legal Fees, Office Expenses, Payroll Expenses, Picnic, Professional Fees, Property Taxes, Unity Magazine and Utilities. Investment expenses are not included.

End of year operating cost as of December 31, 2016

were \$335,039, contrasted to December 31, 2015 figure of \$371,206 and \$737,187 in December 31, 2014. A higher than normal portion of outlays in 2015 and 2014 was spent for legal fees to defend our benefits in the bankruptcy proceedings.

The Association expenses as of December 31, 2017 were \$330,913. The Association had a total income of \$227,670; this number includes \$196,805 in dues and \$30,865 in appreciation, donors and participant contributions. Moreover, \$110,000 of investment earnings was transferred to the Association's fund to deal with expenditures. (The dues assessment of \$36.00 annually does not cover the Association's annual expenses which then, are supplemented by transferring investment funds.)

Left out from the above valuatons is the office located at 2525 E. 14 Mile Road Sterling Heights, Michigan 48310 which is owned by the organization. The above numbers are calculations for members' informational purposes only and are not to be construed as a professional audit and official certified numbers.

TRUSTEE REPORT

As you are well aware, through the dogged effort of your Association and in particular President Don Taylor another piece of legislation was passed which benefits many members. As reported in Volume 131 (Fall 2017) HB 4396 is the tax exemption for former members born after 1952 and retired as of January 1, 2013. Those members will now have the same tax deduction as those that were born between 1946 and 1952.

This affects approximately 750 current members of the RDPFFA. Unfortunately, there are approximately 800 non-members who will also be enjoying this new benefit. I say unfortunately because those are retirees who choose to not pay the exorbitant (said facetiously) YEARLY DUES OF \$36.

Many members besides paying the annual dues send donations earmarked for the general fund, political action committee, etc. As there are approximately one third (1/3) of active members as there once was this means we have less members retiring. Which also means less dues coming in.

Our routine expenses, natural gas, light, property repairs, offices expenses, etc., are not going down. Currently we have made significant conservative investments which keep us afloat and in good shape. However, if any considerable number of the non-members would pay their fair share it would be a shot in the arm.

It is interesting to note that, retired Oak Park Public Safety officer Kevin Loftis has applied to be an associate member of our association. Why? Because he falls into the new category (born after 1952, retired before January 1, 2013) and is grateful for the efforts taken by Don Taylor and this Association to push for a benefit for retirees in general. Myself and your other Trustees, Ken Gidner and Chet Opolski heartily endorse Kevin's application (as well as dues) for 2018. Pursuant to the by-laws the Board of Directors and the general membership will be asked to vote on his application.

Now is the time for those retired non-members to step up to the plate. The approximate cost is less than 1.6% of the max tax exemption. We must keep our presence known in Lansing so that we can possibly extend to those that retired after January 1, 2013. With your continued support we will not stop.

It's Here! The Tax Bill is Final!

Well, after a lot of talk, a lot of smoke, we have some fire. Here is our quick overview on the new tax law. We will be providing as series of guides to the new law in more detail, but we thought you might be interested in a summary and our quick opinion.

1. **It's big.** Yes, it is a big tax cut. By % of GDP, it not the biggest cut. Using that measurement, the 2010 'fiscal cliff' was bigger, the 1981 Reagan ERTA was bigger and the 2012 compromise to make the Bush tax cuts permanent was bigger. But make no bones about it, this was a very large and sweeping cut.

Opinion: The previous big cuts (1981, 2001, 2010, and 1977) were in economic downturns. Despite rhetoric to the contrary, we are not in an economic downturn. We wonder what effects a large cut will make in a reasonably healthy economy.

SIMPLE VERSION: It's big.

2. **It's a cut for most people.** Yes, it is. The bracket rates for individuals go down, the standard deduction goes up, and there are some compromises. After all the haggling, many of the prior losers, like graduate students, medical expenses, and employee education, came out unscathed.

Opinion: Figure this out: if you cut taxes (which for a government is revenue), you either have to cut expenses or have a deficit. This new law will either cause a deficit, or (hopefully) create enough growth to increase revenue to pay for itself. The funny part is that it will be either touted as a huge tax cut, or reviled as a huge deficit increaser. Not surprising, both of those scenarios are likely wrong. It is about ½% of GDP by Treasury estimates, so neither huge in the cut nor huge in the deficit department.

SIMPLE VERSION: It's a cut. People who don't pay a lot of taxes get a cut, people who pay a lot of taxes get a bigger cut.

3. **It's a cut for corporations.** Yes, for most. The prior law was complex and had a wide variety of corporate deductions and credits. The maximum rate was 35%, and is now 21%. Sounds like a huge cut, right? But the S&P 500's effective tax rate is lower than 35%. In fact, the actual average corporate tax paid is well under 21% for many corporations. Many deductions and credits are eliminated, but the overall effect is a tax cut to corporations.

Opinion: This new rate makes America competitive with the rest of the world. Large corporations hire very smart CPAs and tax attorneys to help them legally shield taxes. If it's better to shift profits to Ireland, so be it. It's like Michigan retirees deciding to make Florida their homestead to save on Michigan income taxes. Making the US corporate rate lower makes US corporations more competitive. Allowing immediate expensing of business capital expenditures will encourage businesses, including more foreign companies, to invest in and do business in the US.

SIMPLE VERSION: Corporations get a cut, which makes the US more competitive.

4. **Small Businesses make out.** Yes, by a lot. There are two general ways to set up a business, as a C-corporation (see above), and as a pass-through, like a sole proprietorship, Subchapter S corporation, or a partnership (including LLCs). There are lots of cool things for small businesses in the new tax law. The biggest is a new Code section, 199A, which allows a deduction of 20% of pass-through income. Making it simple (it is not simple, I assure you), say Louise and Tom own a cabinet business. They have it set up as a Subchapter S corporation. They have \$150,000 of pass-through income from the business, and take salaries of \$100,000. They would deduct \$30,000 from their income as Qualified Business Income (QBI). This QBI deduction is a reduction of Taxable Income, and not Adjusted Gross Income. All businesses can now also write-off asset purchases (other than real estate) up to 100%. For smaller businesses with under \$25 million of revenue, they can continue to write-off interest and continue to use the cash method of accounting, versus accrual.

Opinion: The rules are complex, to say the least. The pass-through provisions are an 'equalizer' to the corporate tax cuts. If the pass-through rules wouldn't have changed, C-corporations would have a tax advantage, but the gap now between C Corporations and pass-throughs is much tighter. The new law, in a very complicated way, sets up rules for pass-through businesses that allow the calculation of QBI. There are exceptions for service businesses, like law firms and CPAs. But there is an exception to the exception which we call the 'Poor Lawyer' clause, which lets anyone with less than \$315,000 of income (\$157,500 if you are single) to take the QBI deduction. Overall, this will be a big change for business owners, who now will want to rethink how they conduct business and how they pay themselves. Oh yeah, and at the last minute, they added an additional opportunity for President Trump, Senator Corker real estate investors to use the QBI.

SIMPLE VERSION: Small businesses now have some big opportunities and need to talk to someone.

5. **It's Simpler.** Nope. Thanks Congress. Everyone needs planning and tax advice more than ever. I think they could call this "The Equal Employment Opportunity Act for Tax Attorneys and CPAs". There are massive changes, and a lot of complexity.

SIMPLE VERSION: It's not simpler.

Stay tuned for more on the new law. We'll be publishing a series of guides, and as always, we're available to sit down and have a conversation. It's not often that we get a nice market return coupled with a planning opportunity. 2018 may shape up to be an interesting year.





DEATH OF MEMBER FAMILY ASSISTANCE PROCEDURE

Communications vary whether member was Police, Fire, or Sergeant and above. If you are Police make your first call to the Detroit Police Benefit & Protective Association, (313) 870-9301. Followed by either a call to the Detroit Police Officer Association, (313) 567-8770, or the Lieutenants & Sergeants (313) 961-5699, which ever applies.

While the Detroit Police Benefit & Protective Association will normally contact the City of Detroit with the information it would be reasonable to follow up with a call to the Pension Bureau, (313) 224-3362 Ext. 221 or 1 (800) 339-8344 and Automated Benefit Services (ABS) 1 (800) 645-9978 to make sure that they were notified. Last but not least, notify the Retired Detroit Police & Fire Fighters Association, (586) 795-1734.

Fire employees, start by notifying the Detroit Fire Fighter Association, (313) 962-7546, the Detroit Firemen's Fund Association, (313) 628-0099, Detroit Fire Mutual Fund, (313) 962-4595, and the Detroit Pension Bureau, (313) 224-3362 or 1 (800) 339-8344.

The above agencies will assist you with the notification process. It would be a good idea to put this information with your secured legal documents or some other obvious place where your survivors can locate it.
