



As we begin a new year, I would like to run through the RDPFFA previous year activities, income and expenses from January 1, 2021 to December 31, 2021.

A direct quote from the Restated Bylaws of the Retired Detroit Police and Fire Fighters Association states, in part, "The purposes of the Association shall be: To provide the Members with information concerning the status of Pensions, Hospitalization and Insurances." The organization achieves pension issue goals by supporting two elected pension representatives, one fire and one police, who in return report to the membership on all relevant activities. Hospitalization Benefits, are regularly monitored by elected Trustees, two are RDPFFA Board of Director members who report to the participants all applicable information.

In addition, the Retired Detroit Police and Fire Fighters Association objective is to promote a spirit of good fellowship and a closer personal relationship among members and their families. Attempting to accomplish this goal the Association arranges an annual picnic and coordinates a golf outing. The Association is organized and shall be operated exclusively for the purposes set forth in Section 501(c) (4) of the Internal Revenue Code.

This is a summary of year end numbers compiled by the Retired Detroit Police Fire Fighters Association

Over 6,000 persons were participants in the Association at the end of 2021, of those included, 4,227 started the year and the Association ended the year with 4,064 on payroll deduction. Other members are those not enrolled who pay annually along with persons not eligible for automatic payroll deduction. The following list represents categories identifying annual expenses; Events \$4,800 (14 donations), General Meetings \$5,333.32, Honorariums \$34,085, Insurance \$1,223.66 (Average yearly cost - 3 year policies), Office Expenses \$39,190.36, Payroll Expenses \$116,700, Professional Fees \$5,000, Professional Services \$8,664, Property Taxes \$7,906.79, Unity Magazine \$14,966.76 and Utilities \$9,763. Investment expenses are not included.

The yearly Retired Detroit Police and Fire Fighters Association expenses as of December 31, 2021 were \$261,135. The Association had a total income of \$210,780; this number includes \$167,496 in dues, \$27,214 in appreciation and \$14,028 in other income contributions. Also, \$20,000 of investment earnings was transferred to the Association's fund to deal with expenditures. The dues assessment of \$36.00 annually does not cover the Association's annual expenses which then, are supplemented by transferring investment funds.

December 31, 2020 end of the year total expenses was \$254,692, December 31, 2019 end of the year total expenses was \$261,151, operating cost as of December 31, 2018 were \$301,331 compared to \$316,356 for December 31, 2017, contrasted to December 31, 2016 figure of \$335,039.

Left out from the above values of total assets is the office located at 2525 E. 14 Mile Road Sterling Heights, Michigan 48310-5969 which is owned by the organization. The above numbers are calculations for members' informational purposes only and are not to be construed as a professional audit and official certified numbers.

We continue to monitor legislation both locally and nationally to ensure your benefits are protected. As we have pointed out with a split Government in Michigan not much has been moving in Lansing.

Starting in October of 2022 you will be able to purchase a vehicle license plate that will be valid for two years. With the cost of license plates I'm not sure it will be worth it.

Other legislation we are watching involves a number of Bills relating to CCW laws. Some would be an improvement, while others would not. As of this date none of them are moving.

We are monitoring a number of Bills relating to the Open Meetings Act. We are supporting a change in this Law that would allow for some Board Members to be able to attend the meetings electronically, under certain circumstances. These pieces of legislation do not appear to be moving at the current time.

On the Federal level, once again there is legislation relating to the Social Security Windfall and Pension offset. As has been the case for the past thirty years, there has not been any movement regarding this legislation.

That's about it for now, stay safe and I hope to see you at our Association functions.



DEATH OF MEMBER FAMILY ASSISTANCE PROCEDURE

Communications vary whether member was Police, Fire, or Sergeant and above. If you are Police make your first call to the Detroit Police Benefit & Protective Association, (313) 870-9304. Followed by either a call to the Detroit Police Officer Association, (313) 567-8770, or the Lieutenants & Sergeants (313) 961-5699, which ever applies.

While the Detroit Police Benefit & Protective Association will normally contact the City of Detroit with the information it would be reasonable to follow up with a call to the Pension Bureau, (313) 224-3362 Ext. 221 or 1 (800) 339-8344 and BeneSys (833) 725-5336 to make sure that they were notified. Last but not least, notify the Retired Detroit Police & Fire Fighters Association, (586) 795-1734.

Fire employees, start by notifying the Detroit Fire Fighter Association, (313) 962-7546, the Detroit Firemen's Fund Association, (313) 628-0099, Detroit Fire Mutual Fund call Firemen's Fund Association to leave a message, and the Detroit Pension Bureau, (313) 224-3362 or (800) 339-8344, ext 221.

The above agencies will assist you with the notification process. It would be a good idea to put this information with your secured legal documents or some other obvious place where your survivors can locate it.

Scammer Alert!

Four Signs That It's a Scam

1. Scammers PRETEND to be from an organization you know.

Scammers often pretend to be contacting you on behalf of the government. They might use a real name, like the Social Security Administration, the IRS, or Medicare, or make up a name that sounds official. Some pretend to be from a business you know, like a utility company, a tech company, or even a charity asking for donations.

They use technology to change the phone number that appears on your caller ID. So the name and number you see might not be real.

2. Scammers say there's a PROBLEM or a PRIZE.

They might say you're in trouble with the government. Or you owe money. Or someone in your family had an emergency. Or that there's a virus on your computer.

Some scammers say there's a problem with one of your accounts and that you need to verify some information.

Others will lie and say you won money in a lottery or sweepstakes but have to pay a fee to get it.

3. Scammers PRESSURE you to act immediately.

Scammers want you to act before you have time to think. If you're on the phone, they might tell you not to hang up so you can't check out their story.

They might threaten to arrest you, sue you, take away your driver's or business license, or deport you. They might say your computer is about to be corrupted.

4. Scammers tell you to PAY in a specific way.

They often insist that you pay by sending money through a money transfer company or by putting money on a gift card and then giving them the number on the back.

Some will send you a check (that will later turn out to be fake), tell you to deposit it, and then send them money.


