



### PRESIDENT Don Taylor

As we continue to work through implementation of the Bankruptcy Plan of Adjustment (POA) our focus is to maximize the benefits to our retirees. We are involved in a number of issues at all levels in our attempt to improve our benefits and limit the negative effect of the Bankruptcy.

The Bankruptcy agreement required an election for 2 Retired Pension Board Trustees, these elections have been held and results are as follows:

Greg Trozak elected as the Police Retiree Pension Board Trustee

John Tucker elected as the Fire Retiree Pension Board Trustee

The responsibility of enforcement and implementation of the Detroit Bankruptcy Plan of Adjustment (POA) has been assigned to Bankruptcy Judge Thomas Tucker. He has scheduled a number of hearings to address any remaining open issues. The RDPFFA filed a motion to enforce the POA and require the City of Detroit to comply with a clause in our Term Sheet requiring the City to ensure that if, any other group received a benefit affecting Class 10 or 12 which was more advantageous to retirees then the language contained in our Term Sheet, we were entitled to receive the same benefit.

Our Language under section 8 of our Term Sheet: "Police and Firefighter retirees are entitled to the ben-

efits of any other agreement entered into by the City of Detroit that covers such retired police and firefighters and which is more advantageous to them than the terms of this agreement as it relates to Classes 10 (PFRS Pensions) and 12 (OPEB/Healthcare)."


As part of the Bankruptcy, the City of Detroit entered into an agreement with the Detroit Fire Fighters Association, which is for totally disabled Fire Fighters (including current members of Class 12), The City will pay \$140,000 annually each year for the next 5 years to assist with medical expenses. We filed a motion that totally disabled police are entitled to the same benefit. The motion was heard by Judge Tucker on May 6th and he indicated he would give his decision within 30 days. (As I prepare this article we have not received his decision).

#### **Legislative Efforts**

On the State level, we are working on two pieces of Legislation. The first, which is being sponsored by Senator Ken Horn, would amend the current State Pension Tax Policy which assesses State Pension Tax based on age groups. Those born after 1952 and are between 62 and 66 years of age receive only a \$15,000 deduction for a single or joint return. We are attempting to amend the language to have those born after 1952 placed in and treated same as those born between 1946 and 1952. This would increase their deduction from the \$15,000 to \$35,000 for single and \$55,000 for joint returns.

The second State Issue is in regards to the Voluntary Employee Beneficiary Association, commonly referred to as "VEBA". Under the current Trust Agreement VEBA Trustees are to receive a monthly stipend of \$1000. There is no requirement for attending meetings, and no language for removal of Trustees. In checking the operation of other VEBAs, normally they

I would like to begin by thanking everyone who voted for me and gave me the opportunity to serve as your pension representative on the Police & Fire Pension Board. My votes and decisions will be based on what is best for the system and most of all the retirees and beneficiaries of the pension system.

Since taking the seat there have only been a few meetings scheduled and just sitting in on those meetings it is evident that things have changed since I sat on the sidelines and observed as a visitor. Gone are the days of long lines of so called investors lining up at the door looking for ten or twenty million because they have the sure way of making the system mone. Many of those investments involved the past administration or influencing votes from past trustees. Today the meetings are strictly business and making sure the investments that remain will continue to perform. The system continues

KEVIN GREENE (586) 790-7908 16414 WALCLIFF CLINTON TOWNSHIP, MI 48035 to pursue legal action in an attempt to recover the money lost from those past investments. The pension system is presently funded at 3.2 billion dollars and the gains continue with today's markets.

This brings us to the restitution of benefits that is a concern of those that saw a cost of living reduction in March of this year. As of this writing nothing has been decided. This is due to the change in the way the pension system is funded. The active employees have a new hybrid type pension and the latest actuarial report from June 30, 2014 shows the system prior to bankruptcy when this was not in place. The actuarial firm is in the process of getting a report with updated numbers that should show the gains the system has made including the present day numbers. This report should be available late June or early July. This report should show whether some sort of restitution will be sustainable.

Those that do see a cost of living adjustment annually will see a little over 1% increase on the August check which should return the amount of the pension checks back to what they were prior to March.

Those members under the "Old Plan" should see an increase in their pension next year in July, 2016. This is the time frame for the actives to get the pay raises they are scheduled to receive from their new contracts. We know that it has been a long time since "Old Plan" members have seen any increase, so there is a small light at the end of the tunnel. I will continue to keep everyone updated as more information become available.

I did mention above about the old administration and trustees, well those that were convicted in Federal Court have had their sentencing postponed again until the end of July and early August. Stay tuned, it should be interesting.

Now I would like to get into VEBA. This continues to be a work in progress and I'm sure will continue to cause concern through this year. One thing to remember

Thirty five years ago the Association, located at 3456 E. 12 mile Road, Warren, MI, published a "Newsletter" with the slogan "Voice of the Retired Police and Fire Fighters". The information provided was: The President Speaks, Chairman of the Board Reports, Our Secretary's Views, in addition to reports on Pension activities, Hospitalization updates and/or news, finishing up with Coming events, Legal notice(s) and an Editors comment. The paper always recognized supporters who contributed designating their donations to specific funds such as the Associations Building Fund or Political Action Committee while others were labeled as "Appreciation" donations as well as the numerous thank you and appreciation letters mailed to the office.

In May, 1993, the Association moved to a new location located at 5701 Chicago Road Suite A, in Warren, MI. The quarterly publication was renamed to its present name familiar to all as the "Unity". In January, 1994, Volume Five, "In Memoriam" was added recognizing Police and Fire personnel that passed in November and December of 1993. This acknowledgment continues to this day.

On April 1, 1996, the Association moved to its present location which is 2525 E. 14 Mile Road, Sterling Heights, MI. An "Open House" was celebrated on September 18 and 19, 1996. The facility was purchased and paid off within a few years thanks to generous donations from our members.

Earlier, I wrote about a "Newsletter" that was presented to the members. It was distributed four times a year from 1980 to 1992. In 1993, the expanded and newly named magazine known as the "Unity" was presented six times a year, one every other month starting in January. On October 21, 2009, the Retired Detroit Police and Fire Fighters Association Board of Directors decided to reduce the Unity's distribution to four times a year, January, April, July and October. It was also decided that if a supplemental newsletter would be

needed it could be prepared for distribution. Believing that the Association was able to provide the membership with the expected information, it was generally thought that the members would understand that this change was approved to reduce cost and save money.

The "Unity" will continue to be distributed quarterly but the magazine will not always arrive at the beginning of a quarter. To provide our members with the most up to date information, occasionally we will hold distribution waiting for pertinent information to be released. A slight inconvenience, although we believe a necessary one. As a result the magazine will be published and delivered in the winter, spring, fall and summer, the way it used to be, thirty five years ago, 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> quarterly publications

meet quarterly and I did not find any VEBAs in Michigan that provide any compensation (other than reimbursement of expenses) to any Beneficiary Trustees. There was an option agreed to in the Bankruptcy, under the agreement with the Syncora Group, which would have placed a requirement for Trustees to attend meetings in order to be compensated and capped the compensation at \$250.00 per meeting. This option required approval of the Trustees, which they did not agree to. Now any changes to compensation require 6 out of 7 of the Trustees to agree, which I believe is not likely to happen. State Representative Andrea LaFontaine has agreed to sponsor legislation that would cap compensation, require meeting participation, and cover removal language, for VEBAs established through a Federal Bankruptcy.

On the Federal level, first we are working with Congressman Mike Bishop and his staff, in an attempt to modify the language regarding Public Safety Officers and retirees under current tax law which allows for deduction of up to \$3000 in Healthcare premiums on Federal Tax only if the premiums are deducted from pension check.

Second we are also looking into amending a current a Federal Healthcare Tax Credit which would assist with Healthcare premiums.

Legislation is expensive and time consuming, but under the current situation we find ourselves in, there appears to be no other option to help get back some of our healthcare benefits which we loss through the Bankruptcy.

Again I must ask for your assistance in funding these efforts. Now that we are actively pursuing legislation, we need to replenish our PAC Fund. I ask those that can to donate to either the Legal Fund or the PAC Fund. We cannot use General fund money for the PAC, and without the resources we don't stand much of a chance of accomplishing our goals.

for those that are on Medicare and have the City sponsored plan is that nothing will change this year. You will have the plan you choose with no changes for all of 2015. We are working with the carriers in an attempt to possibly continue with the plans presently offered. There is no guarantee that they will even offer any plans but we are asking. Should any changes happen everyone will be notified in plenty of time to make any changes that may be necessary.

For those pre-Medicare or non-Medicare eligible retirees you were all changed to a Health Reimbursement Account (HRA) effective April 1, 2015. The reason for the change is the Federal Government does not allow VEBA's to pay a stipend. You should have been notified by Flex Plan of the change and advised on how to set up your account. We understand that once the account has been set up the process works well. Yes, there are a few glitches that we are in the process of fixing, it just takes time and we ask that you bear with us while the process works out. The main problem that we have found is the data, the City should supply the companies that they hired, is unreliable and outdated. Once this is resolved it should help correct the problems that have surfaced.

The new HRA's should have begun being funded with the same amount minus a \$5.00 service charge that members received in stipend money. These accounts should be used to submit medical bills that were paid by the member for reimbursement. This process will also continue through this year. The VEBA Board is in the process of looking for a Third Party Administrator (TPA) who will handle all of the administrative duties beginning January 2016. Once the TPA is secured the plan is to have an open enrollment sometime in the fall for all members to make any changes that they may want or need to make. There will be more information on this coming in the next few months.



Communications vary whether member was Police, Fire, or Sergeant and above. If you are Police make your first call to the Detroit Police Benefit & Protective Association, (313) 870-9301. Followed by either a call to the Detroit Police Officer Association, (313) 567-8770, or the Lieutenants & Sergeants (313) 961-5699, which ever applies.

While the Detroit Police Benefit & Protective Association will normally contact the City of Detroit with the information it would be reasonable to follow up with a call to the Pension Bureau, (313) 224-3362 or 1 (800) 339-8344 and Human Resources (313) 224-4809 or 1 (888) 288-2684 to make sure that they were notified. Last but not least, notify the Retired Detroit Police & Fire Fighters Association, (586) 795-1734.

Fire employees, start by notifying the Detroit Fire Fighter Association, (313) 962-7546, the Detroit Firemen's Fund Association, (313) 628-0099, Detroit Fire Mutual Fund, (313) 962-4595, and the Detroit Pension Bureau, (313) 224-3362 or 1 (800) 339-8344.

The above agencies will assist you with the notification process. It would be a good idea to put this information with your secured legal documents or some other obvious place where your survivors can locate it.

### **Deconstructing the S&P 500:**

How 36 Stocks Gave You 55% of the S&P's Return in 2014

Like a lot of investors, I watched the S&P 500 Index do very well in 2014, especially compared to holdings in small caps, international, and emerging markets. We own the S&P 500 index as a holding and I'm happy about that. However, I couldn't help wonder how the S&P did so well. The pundits were decrying the death of active management, and new records on the S&P fell daily as the rest of logical investments sat relatively idle. So, I worked out a trusty spreadsheet with help from friends at Highland Capital, and deconstructed how the S&P did. The results are startling: 36 stocks out of 500 provided over 55% of the total return.

Knowing what the S&P 500 is made up of is important. Essentially, it is an index of 500 stocks selected by the S&P US Index Committee. It's not—contrary to popular belief—the 500 biggest US stocks. The S&P 500 is based on market capitalization, so a big company occupies a much larger portion. Apple, for example, is one stock out of 500, or 0.2% of the total number of stocks, but it is 3.25% of the weight of the index. Apple's return has a very big effect on the overall S&P return (more on this in a minute). WPX Energy is another stock in the S&P 500, but makes up only 0.0058% of the Index. The bigger the company, the more it affects the index and, subsequently, how it performs. Southwest Airlines was the best performing stock in the S&P 500 last year (low oil prices helped, and I suppose they save big on meals), but its only 0.11% of weight of the S&P, so it's 126% return only added .73% to the S&P's total return.

#### Now for the deconstruction:

- The top 36 stocks in the S&P 500 provided over 55% of the total return of the S&P for 2014.
- The top 5 stocks (Apple, Microsoft, Berkshire Hathaway, Intel and Wells Fargo) contributed almost 20% of the total return of the index.
- Apple by itself contributed 8% of the total index return for 2014, while Exxon contributed a negative 1.17%. Apple contributed almost a third of the total amount from all technology stocks.
- 35% of the stocks made all of the return for the year.
- Real estate is only about 2% of the S&P 500, but provided 4.25% of the total return.
- Energy was an obvious drag.

What's the moral of the story? We all know that diversification is key, but this review should be enlightening.

You only needed 35% of the S&P 500 to get all of your return, but which 35%? It reminds me of a story attributed to John Maynard Keynes, who was asked how many stocks you needed to own. His response was "One". The interviewer then asked "Which one"? Keynes replied, "The one that makes the most money." The interviewer then asked, "How do I find that one?" Keynes' famous response: "Wish I knew!" So for 2014, you may have loved Apple, but you were really happy with Southwest Airlines (+126.3%). You were probably unhappy with Transocean (-59.9%). But if you owned the whole basket, you owned them all. It's the concept of diversification: have parts of the whole world, and enough to make sure you own the winners.




