State Representative Fred Durhal Jr. Takes up our Battle "Right to Vote / A Question of Fairness"

Our continuing struggle for equal and fair voting rights for Retired Detroit Police Officers and Fire Fighters has a new champion for our cause.

State Representative Fred Durhal Jr., working in conjunction with our lobbyist Tim Ward, introduced House Bill 4917. This bill would give Retired Detroit Police Officers and Fire Fighters an equal vote for elective representatives of the Detroit

Police and Fire Pension System. For far too long Retired members of the Detroit Police and Fire Pension System have been denied a basic American Right, to vote for those that claim to represent you. We are not the first group to be deprived of this basic American Right, and this point was very effectively and elegantly pointed out by Representative Durhal.

Representative Durhal also took the time to attend our General Membership meeting May 7th, to address the members. Following his presentation, I believe the 300 or so members in attendance agreed that we have the right person in our corner.

Now it is time to let our Representatives know that we want them to Co-sponsor and pass this bill. Elected Officials have told us that they are more impressed when their constituents contact them in person or by letter. Other ways to contact them would be by phone and / or email. Normally we would ask that you not share our correspondence with non-members, but in this case we want everyone involved who can assist us in obtaining our goal, i.e. family members, friends, neighbors, retired police and fire non-members, so please spread the word. Do not just sit back and let this opportunity to right this wrong slip away. Although this may seem like an issue, which appears to be very difficult to rationally oppose, rest assure there will be those lining up on the opposing side.

We will track the progress of this legislation and list the co-sponsors on our web-site rdpffa.com. A number of Representatives have already signed on as co-sponsors; their names are listed in this article. We will also print a partial copy of the Bill in this issue of Unity (HB 4917) on page 3, in the Pension column.

We have all been impacted by the recent economic decline. The Association's Board of Directors has taken steps that will confidently assist the RDPFFA in cutting expenditures during these frustrating times. though these steps are considered temporary, only the future will determine that outcome. These cuts were made across the board, some I agreed with and others I did not.

Over the past year we have had additional substantial costs, namely attorney fees. I'm sure everyone will agree that we all loathe paying legal representative costs, but this is something that is necessary. The main goal of this Association is to protect the rights we have earned for our years of service to the City. This must be absorbed and the fight continued.

Additional expenses include postal cost. The past year was substantial because of the switch to the dues being collected by payroll deduction. We knew that there would be additional cost but now that the program has been in effect for nearly a year the future expense will be diminished substantially. The postal cost also included a mass mailing in an attempt to gain nonmembers. This has also shown to be some degree of a success. The Association signed up close to 400 new members of which many have requested to pay their dues by having them payroll deducted.

Other cost cutting measures have also been enacted resulting in additional savings, including reducing honorariums for officers and board members, reducing the size of the Board of Directors through attrition, using our tax exempt status for the mailing of the "UNITY" newsletter, reducing our accounting fees, stopping or reducing donations for events or functions within the Association and dropping out of the National Association of Police Organizations (N.A.P.O.).

I will continue to support any expenses that benefit our members, this includes General Meetings, Association Sponsored Events and any spending needed to protect our rights that we have earned or may help us gain additional profit in the future. This is the reason I was against dropping out of N.A.P.O. and I will state my reasons. The main reason being, N.A.P.O. continues the fight to bring to an end the Windfall Elimination Provision (WEP) and the General Pension Offset (GPO). We all know that this has been an ongoing fight for several years with still no legislation signed into law. This legislation, which would totally repeal the GPO and WEP, has been introduced in both Houses, H.R. 235 in the House and S. 484 in the Senate. N.A.P.O. is optimistic that with the new Congress these bills will move out of committee and on the House and Senate floors for debate and then signed into law by the Administration. In 2008 N.A.P.O. had assisted our organization in providing sample letters used in contacting members of Congress along with updating us on the progress of these two (2) bills.

Another important piece of legislation that was signed into law was the Healthcare Enhancement for Local Public Safety (H.E.L.P.S.) Retirees Act. H.E.L.P.S. Retirees Act allows public safety retirees to use up to \$3,000.00, federal income tax-free, annually



## House Bill Number 4917

In lieu of the pension article for this issue we will include a partial copy of House Bill number 4917, a bill to amend 1947 PA 336, that pertains to allowing the Retired Detroit Police Officers and Fire Fighters an equal vote for elective representatives of the Detroit Police and Fire Pension System.

- 18 (5) IF COLLECTIVE BARGAINING BETWEEN A CITY WITH A POPULATION
- 19 OF 500,000 OR MORE AND ITS POLICE OR FIREFIGHTING EMPLOYEES RESULTS
- 20 IN A REQUIREMENT THAT THE BOARD OF TRUSTEES OF THE POLICE OR
- 21 FIREFIGHTERS' PENSION OR RETIREMENT SYSTEM INCLUDE 1 OR MORE
- 22 REPRESENTATIVES OF MEMBERS OF THE PENSION OR RETIREMENT SYSTEM OR
- 23 OF THE COLLECTIVE BARGAINING UNIT, THE METHOD OF SELECTION OF THOSE



since our last issue; however Detroit City Council did approve the settlement. We were waiting for a certified copy of the resolution that City council passed approving the settlement, and for all the Unions to sign off. As I write this article on Sunday, May 11, Attorney Chris Legghio has advised me, that on Monday, May 12, he will file a motion with Judge Torres requesting a hearing in which he will seek to have the Judge approve the settlement and give the go ahead to implement the settlement, with or without the Unions signing off and with or without the certified copy of the resolution from City Council. It appears that the implementation of the settlement will probably not take place until August or September. Once everything is in place, you will receive a letter from the attorney explaining the details of the settlement. We will keep you updated.

Next item of concern is our lawsuit regarding the misuse of the money from our pension system. Just a little reminder of what took place. The city and the active unions entered into an agreement in which the city was allowed to forgo paying 75 million dollars into the pension system, in exchange for the active unions receiving increased payout on their sick time, and using 25% of the

value towards their average final compensation on their pension. This case has been bouncing around from the Chief Judges to Judge Murphy for several months now.

On Thursday, May 7, a status hearing was held with Judge Murphy, during which he questioned the attorneys present regarding the portion of the lawsuit dealing with superintending control. (Superintending control, if granted would reverse the decision of the pension board and require the city to pay in the full amount they were originally required to pay, prior to agreement between the unions and city.) The attorneys representing the Unions, City and the pension Board, told Judge Murphy that they believed based on the responses from Chief Judge Giovan and Chief Judge Virgil Smith, that the portion dealing with superintending control had been dismissed. Our attorney Mike Stefani disagreed with their opinion.

Judge Murphy advised our attorney, based on the information he has now, that if our side did not agree to drop the superintending control portion, and the other side filed briefs requesting it be dismissed, he would dismiss the superintending control issue. At which time we could appeal his decision to the Michigan Court of Appeals. Although appealing to the Michigan Court of Appeals would delay our portion of the lawsuit seeking damages from the City, unions and pension board, at this time we believe the superintending control portion is important and that the action of the pension board was improper and should be reversed. Therefore, at this time if the court dismisses the superintending control issue, we are intending to appeal the case to the Michigan Court of Appeals. Our next court date with Judge Murphy is June 18, these issues may be resolved on or before that date. We will keep you updated, regarding this matter.

In the last issue of the Unity we requested information from our membership regarding those that were paying dues to the LSA and the DPOA. We are still researching the possibility of taking legal action against the LSA and DPOA for violating their fiduciary responsibility to their associate members by collecting dues from them, and then using those funds to actively work against their best interest. If we find it necessary and believe it to be in the best interest of our members this lawsuit might be filed shortly. We will keep you updated.

On Friday April 3rd, I met with the Presidents of the DPOA, LSA, DFFA, and Vice President of the DCOA. During this meeting, it was articulated by the unions that they did not intend to interfere with the settlement

of our hospitalization lawsuit, and that it had just been a misunderstanding, due to a lack of communication. They also stated that they had, in the past supported issues concerning Retirees and that we all should work together. However, since that meeting we have been getting some mixed messages. We remain ready to meet with any of the Unions or the City regarding any or all of the issues that I have raised in this article, and I agree that it is time that we work together to resolve our issues outside of the court rooms. We are watching to see some sign of action by the unions to support their words.

Over the next several months you will receive information from John Hancock regarding Long-Term Care. Many of you have expressed an interest in this type of coverage so we have agreed to assist representatives of John Hancock with getting the information out to our members. A letter signed by me will be included in the package of information you receive. The purpose of my letter is to inform you that this program is available, and our members will receive a discount and by you seeing the information on our letterhead, you can rest assured that we are handling the mailing and not releasing addresses of our members to anyone. If you are in need of Long-Term Care insurance now, you should contact Karen Whelan (Rivest) at her office. (313) 963-4004

Our membership has reached its highest level ever at nearly 6800 members. We still need everyone to monitor our non-member list, and contact anyone that you may know, and suggest that they do their part. We all need to share in the responsibility of protecting the rights and benefits of Retired Police Officers and Fire Fighters.

I ask that everyone that receives a pension, and has not signed up to have your dues deducted from your





While the Detroit Police Benefit & Protective Association will normally contact the City of Detroit with the information it would be reasonable to follow up with a call to the Pension Bureau, (313) 224-3362 or 1 (800) 339-8344 and Human Resources (313) 224-4809 or 1 (888) 288-2684 to make sure that they were notified. Last but not least, notify the Retired Detroit Police & Fire Fighters Association, (586) 795-1734.

Fire employees, start by notifying the Detroit Fire Fighter Association, (313) 962-7546, the Detroit Firemen's Fund Association, (313) 961-2988 or 1 (877) 961-2988, Detroit Fire Mutual Fund, (313) 962-4595, and the Detroit Pension Bureau, (313) 224-3362 or 1 (800) 339-8344.

The above agencies will assist you with the notification process. It would be a good idea to put this information with your secured legal documents or some other obvious place where your survivors can locate it.


