



I hope everyone is enjoying their summer break. As you spend time with your family and friends over the summer don't forget to save a little time to participate in some of the activities offered by the Association, Picnic August 14th, Golf Outing August 20th and the Las Vegas Convention September 20-24 at the RIO Suites.

Speaking of the Las Vegas convention, we have sold out on the Air and hotel packages, but we still have rooms held at Rio Suites. If you are attending and need a room, just give the office a call and ask for me or Jack Devoy.

On to the business at hand. We are still waiting on the Chairman of the Labor Committee to have his committee vote HB4917 out of committee and on to the full house. It is unfortunate that this is taking so long, but as we are finding out, that is the way politics works. We believe we have the votes to pass the legislation out of the Labor Committee, but once it reaches the House floor we will need your assistance. Once again we will be asking for you to contact your Representatives to vote for HB4917.

As you may or may not know the reason for the delays have been, the involvement of some of the large labor organizations, AFLCIO, ASME, UAW, and others have expressed concern that the legislation would

have an affect on Public Employees Relation Act (PERA). This is not the case and we have had our attorneys testify to the fact that this legislation will not have any affect on PERA. But the large labor organizations were able to convince the Leadership of the House that if they were given some time they would be able to work with and assist the local unions (DPOA, LSA, COA, DFFA) in resolving the issue outside of the legislation.

As we now know no meetings were called and no real attempt was made to bring the parties together to resolve the issue. We were informed as was the Chairman of the Labor Committee by the President of the DFFA that they had placed the issue on the table as part of there final offer in the current Act 312 proceedings. As of this date we are not aware of the language that the DFFA has requested regarding the Pension Board issue. We believe that although we appreciate the DFFA taking the issue up at their Act 312, this will not resolve the issue. This is only the DFFA, and to our knowledge this language was not discussed with or agreed to by the others Unions, and in order for any changes to be implemented all four of the Unions would have to have the same language in each of their contacts. That is why we had suggested if any agreements outside of the legislation were to be pursued it should be in the form of a Memorandum of Understanding (MOU). Which would allow all of the Unions to amend their respective contacts at the same time outside of Act 312. So absent a uniform effort by the Unions to resolve the issue, we have no choice but to continue to pursue the legislation. Our members deserve a voice on the operation of their Pension System and we intend to continue to pursue this matter until we have an equal voice with the actives. We will

I would like to begin by updating everyone on the results of the elections held for the two (2) positions on the Pension Board. Trustee Jeff Pegg from the ranks of the Fire Department ran unopposed and thus will serve for the next three (3) years. On the Police side of the aisle will sit a new Trustee. The new Trustee is Matt Gnatek, a Sergeant assigned to the Homicide Section. Matt defeated two (2) term Trustee Marty Bandemer in the election. Matt appeared at our Association's June General Meeting as a guest and stated he would keep our members informed and would represent everyone equally during his term on the board. Congratulations to both Matt and Jeff and all we ask is to be represented equally and fairly.

Continuing with the pension theme, it appears as of this writing that HB 4917 is again on hold until sometime this month. Apparently an active union(s) talked to the right people and on the night of May 18, just

After the 21 day delay the Fire Fighters union submitted a letter to the Chairman of the Labor Committee stating that the retirees concern may be addressed in their Act 312 proposal to the City but they could not state the portion that would help us. In the end the delay continues until sometime this month. As of this writing there is no schedule set for the summer recess for the Legislature so the delay may continue through this month. So keep a close eye on the website and your e-mail inbox.

It seems that HB 4917 draws a lot on attention to the Detroit Fire Fighters Association (DFFA). One of their Officers wrote his entire article in the DFFA magazine about the legislation and our Association. He seems to think our "beer drinking, pizza eating and storytelling" members should sit back collect our pensions and be happy. Well a lot of us do enjoy eating pizza, having a few beers and we have some of the best stories ever told, but we are not going to sit back and not be heard from. He seems to think that the fighting and bargaining with the City just started during his time being an active employee. The battle has been ongoing for years and years and yes our retired members were involved in many of these battles and I'm sure there will be many more in the future. So no, we are not going to sit back, drink our beer and eat our pizza. HB 4917 would give our eligible members the right to vote for the active employee(s) who are seeking election to the Board of Trustees on an equal basis, i.e. according to the department (Police or Fire) retired from, rank achieved upon retirement. This method of voting is spelled out in all the union contracts very specifically. All we are looking for is an equal voice.

I cannot sit back idly without a comment on this one. The subject of working conditions and length of life is a concern of many in public safety, and that includes retirees, but before the writer declares martyrdom he should not overlook, a laundry list of hardships that his predecessors - Fire and Police - had to endure as well as dangerous conditions. My response to Local 344 not undertaking negotiating responsibilities for retirees is that someone made time with pension money to negotiate retirement benefits for active members in addition to relieving the city of three annual contributions, worth 75 million dollars.

The perception is that the Fire union leadership is carrying the water for the 3 other unions - DCOA, DPLS and DPOA, who quietly sit back while all four object and/or block Retirees from having a voice on our pension fund. Most of his article lacks respect for his predecessors both Police and Fire. Adding, "They get together to drink beer, eat pizza and tell old stories". In my opinion the writer's tone is sarcastic and disrespectful to all retirees.

At the hearing of HB4917 in front of the Labor Committee, Detroit Fire personnel (the Union President and Secretary) proudly spoke of their long history of Firefighters and Police Officers on the department and then have a fellow elected officer of the Fire Fighters Association respond in this manner - What a shame to go this route! He continued with his writing, "this social group (Retired Police and Fire Fighters Association) is not recognized as having the ability to negotiate anything". I have heard more than once by actives in elected positions, "You got yours, now it's our turn". This selfish way of thinking is the problem.

All along Retirees have stated that we support active efforts to negotiate with the City the best contract that both sides can agree with, although we maintain one stipulation and that is - do not negotiate any reduction in earned retirement benefits. The Retired Detroit Police and Fire Association had to take action when union bargaining personnel, some elected as Police and Fire Trustees, negotiated benefits with pension funds for the city and active personnel. Some will say that it has been done before and that is true, but it does not make it right and that course of action must stop! HB4917 got its beginning when retirees were left out of a distribution equation. The Retired Detroit Police and Fire Fighters Association were systematically being ignored with stall tactics and statements that amounted to, you got yours now move out of the way.





He states that we should use our resources to force the City to enforce the City Charter for our seat on the Pension Board. Well this Association did this a few years ago and we did win in the local courts only to have the case appealed and overturned by the Court of Appeals. The reason the appeals court overturned the award was because this is a "negotiable item" and must be decided in negotiations with the City and the active unions. So this is where we stand now, still with no voice. If the DFFA Officer has a problem with our Association we have always stated that we will meet and talk at anytime and anyplace. Also he seems to think that the leadership of the RDPFFA is failing to keep its members informed and attempting to build this Association on "untruths". I would personally request that if any of our members feel this is the way this Association is headed please let me know immediately. Moving on to other matters, on the Federal Government side of issues I would like to address the General Pension Offset (GPO) and the Windfall Elimination

keep you updated on the progress of HB4917, and will be calling on you for your assistance as needed.

On a related matter, as you are know we were recently involved in the formation of a statewide organization (Michigan Association of Retired Public Employees). As we worked on our issue in Lansing, I found that we were on our own. It was us against numerous labor organizations representing active members. Although we have been successful in maintaining our support among the State Representatives, these are elected officials, so to them numbers are extremely important. I believe that we should not count on the active Unions to protect our benefits; it is up to us to protect our own. As we know the benefits of Public Employees, both active and retired are now coming under attack on an almost daily basis. Currently the Legislators in Lansing are purposing a number of changes in State law that may have a negative affect on the benefits of Public Employees. We must continue to monitor the legislation and take action to insure that our voices are heard.

Communications vary whether member was Police, Fire, or Sergeant and above. If you are Police make your first call to the Detroit Police Benefit & Protective Association, (313) 870-9301. Followed by either a call to the Detroit Police Officer Association, (313) 567-8770, or the Lieutenants & Sergeants (313) 961-5699, which ever applies.

While the Detroit Police Benefit & Protective Association will normally contact the City of Detroit with the information it would be reasonable to follow up with a call to the Pension Bureau, (313) 224-3362 or 1 (800) 339-8344 and Human Resources (313) 224-4809 or 1 (888) 288-2684 to make sure that they were notified. Last but not least, notify the Retired Detroit Police & Fire Fighters Association, (586) 795-1734.

Fire employees, start by notifying the Detroit Fire Fighter Association, (313) 962-7546, the Detroit Firemen's Fund Association, (313) 961-2988 or 1 (877) 961-2988, Detroit Fire Mutual Fund, (313) 962-4595, and the Detroit Pension Bureau, (313) 224-3362 or 1 (800) 339-8344.

The above agencies will assist you with the notification process. It would be a good idea to put this information with your secured legal documents or some other obvious place where your survivors can locate it.

#### RDPFFA 2010 Election Rules

Only Active Members are eligible to run for office, Associate Members are not eligible to run, or vote in elections. Candidates are not eligible to run for more than one elected position within the Association, Candidates may be nominated for any number of positions, but may, only accept and run for one position.

Nominations for offices will open on September 1, 2010 and will close on October 7, 2010, at the General Membership Meeting. Candidates for office may have their names entered into nomination during the nomination period at the RDPFFA office or at the September or October 2010 General Membership meetings.

The Chairman/Representative of the Election Committee will take Nominations from the floor at the September and October General Meetings. At the October General Meeting the Election Committee Chairman/Representative will close the nominations for all offices. For a Candidate to have his/her name appear on the election ballot, he/she must accept the nomination in writing within 14 days of being nominated.

Following the close of the acceptance period, the Election Committee will cause the election ballot to be prepared, and insure that all Candidates listed have accepted the nomination, and that all Candidates are current Active Members of the Association. If only one Candidate has been nominated for an office and has accepted the nomination, then the Candidate will be considered elected, and no election shall take place for that position.

Ballots will be mailed to all currently listed active members on November 1st, 2010; along with the ballot a specially printed return envelope will be included. In order for a ballot to count it must be returned to the RDPFFA office by November 21st, 2010, and must be returned in the specially designated return envelope. As election return envelopes are received at the RDPFFA office, the envelopes will be counted, remain sealed and placed in a lock box designed for such purpose by the Election Committee.

Voided ballots will be kept separately; the Election Committee will count and tally the ballots prior to the December General Membership Meeting. During the ballot count observers will be allowed as well as candidates or their designated representative. It shall be the duty of the Election Committee Chairman to provide instructions and appoint personnel to count ballots.

The Committee at their discretion may recount any or all ballots cast. Any candidates may request the Committee to conduct a recount in any contested position for which they were candidates within 7 calendar days of the December General Meeting. The request to the Election Chairman must be in writing and signed by the candidate making the request. Recount requests shall not be honored by the Committee if their total count for any office being contested shall show an identical count total for two consecutive tallies. All election results will be announced prior to the end of the December General Membership meeting. All ballots will be maintained at the RDPFFA office for a minimum of 60 days following the election.


