## PRESIDENT Don Taylor

As we move into the summer months and Detroit's Emergency Manager Kevyn Orr moves forward with the financial restructuring of the City of Detroit, you will no doubt hear numerous rumors about proposed changes to pension and healthcare benefits. I would not put a lot of stock in these rumors, they are just that.

We will do our best to keep the membership up to date on any actual proposals that may have an effect on our benefits. It is important that you keep in mind; however that for the time being these are just proposals if and when there are actual confirmed changes and implementation dates, then; we will put out the details as soon as they are available.

In the meantime, please understand that the Emergency Manager does not have the unilateral authority to make changes in current retirees' vested pensions or to alter the Healthcare Settlement Agreement (Weiler vs City of Detroit). Retirees will have a voice in what, if any, amendments are made. If and when, the City of Detroit goes into a Chapter 9 Municipal Bankruptcy, then the question of the authority of a U.S. Bankruptcy Judge comes into play. Bankruptcy law is a powerful tool, but there will be a lot of novel questions.

One of the most important legal questions that has not as yet been fully addressed in the U.S. Bankruptcy Courts is the question of pensions protected by a state constitution, as Michigan pensions are. The full extent of this protection will have to be explored as part of the process. And there are a number of other legal issues that must be dealt with as well, while all of the constituents analyze the various restructuring alternatives.

Representatives of the RDPFFA will continue to attend the meetings with the Emergency Manager or his representatives. We will listen and participate in the discussions regarding any proposals. We will study options, and we will do our very best to protect our benefits.

As our attorney put it, "we are in the very early innings of this financial restructuring and it is going to take some time to work through the process". We intend to be playing for the entire game.

The following is a summary of the June 20, 2013 Meeting (this is only a summary-see note below).

#### RETIREE HEALTHCARE

Medicare Eligible Retirees, Proposed solution effective 1/1/2014

Provide retirees a choice of:

- 1. City paid fully insured prescription drug only benefit, or
- 2. City paid fully insured modest medical and prescription plan

Each option will have the same cost to the City, targeted monthly premium reimbursement of \$100 to \$130 per retiree. City to pay annual increases of up to 3%; retirees to assume additional premium increases.

**Pre-Medicare Retirees,** Proposed solution effective 1/1/2014

City creates and sponsors Retiree Health Reimbursement Account (HRA) for pre Medicare retirees between the ages of 55-64 and for pre-65 duty disabled retirees. Other retirees under the age of 55 would not be eligible for coverage by the City.

The HRA would provide a monthly stipend that

## PENSION TRUSTEE

At the time this article is being submitted to the Unity Magazine, there is not a lot of information from the Emergency Manager (EM) to the Police and Fire Retirement System (PFRS) that has not been published to the public. There is one important piece of information I would like to detail at this time.

The pension fund has formed a restructuring team (the PFRS Restructuring Team) to protect pension fund assets and rights throughout the pre-filing EM restructuring process and the Chapter 9 case, if a bankruptcy filing occurs. The team consists of Greenhill LLC., as the restructuring advisor and Clark Hill PLC., as the restructuring counsel. The primary goal of the restructuring team is to preserve the pension fund's right to receive from the City the annual employer contributions required by state law and protect the lawful composition of the board of trustees. The latter part means and includes challenging any attempt by the EM to unlawfully change the board composition, including the removal of a retiree trustee.

The PFRS will present more information as it becomes available and appropriate for distribution. The PFRS web site (pfrsdetroit.org) is one media source utilized for the distribution of information.





## **RDPFFA 2014 Election Rules**

Only Active Members are eligible to run for office, Associate Members are not eligible to run, or vote in elections. Candidates are not eligible to run for more than one elected position within the Association, Candidates may be nominated for any number of positions, but may, only accept and run for one position.

Nominations for offices will open on September 1, 2013 and will close on October 3, 2013, at the General Membership Meeting. Candidates for office may have their names entered into nomination during the nomination period at the RDPF-FA office or at the September or October 2013 General Membership meetings.

The Chairman/Representative of the Election Committee will take Nominations from the floor at the September and October General Meetings. At the October General Meeting the Election Committee Chairman/Representative will close the nominations for all offices. For a Candidate to have his/her name appear on the election ballot, he/she must accept the nomination in writing within 14 days of being nominated.

Following the close of the acceptance period, the Election Committee will cause the election ballot to be prepared, and insure that all Candidates listed have accepted the nomination, and that all Candidates are current Active Members of the Association. If only one Candidate has been nominated for an office and has accepted the nomination, then the Candidate will be considered elected, and no election shall take place for that position.

Ballots will be mailed to all currently listed active members on November 1st, 2013; along with the ballot a specially printed return envelope will be included. In order for a ballot to count it must be returned to the RDPFFA office by November 21st, 2013, and must be returned in the specially designated return envelope. As election return envelopes are received at the RDPFFA office, the envelopes will be counted, remain sealed and placed in a lock box designed for such purpose by the Election Committee.

Voided ballots will be kept separately; the Election Committee will count and tally the ballots prior to the December General Membership Meeting. During the ballot count observers will be allowed as well as candidates or their designated representative. It shall be the duty of the Election Committee Chairman to provide instructions and appoint personnel to count ballots.

The Committee at their discretion may recount any or all ballots cast. Any candidates may request the Committee to conduct a recount in any disputed position for which they were candidates within 7 calendar days of the December General Meeting. The request to the Election Chairman must be in writing and signed by the candidate making the request. Recount requests shall not be honored by the Committee if their total count for any office being contested shall show an identical count total for two consecutive tallies. All election results will be announced prior to the end of the December General Membership meeting. All ballots will be maintained at the RDPFFA office for a minimum of 60 days following the election.

## **Good News is Bad News** and **Bad News is Good News**

The markets have been interesting lately, to say the least. At the June 19 Fed meeting, Chairman Bernanke indicated that a strengthening economy would cause the Fed to 'taper' its bond buying activity commonly known as QE3 (Quantitative Easing 3, no one really remembers QE1 and QE2 because they really didn't work.) The Fed Chairman then proceeded to repeat a statement almost verbatim that he had said in several previous press conferences. As the economy got better, the Fed would not need to keep pumping money into the system. I likened it to the doctor saying, 'As your hip gets stronger, we can wean you off of the pain medication'.

Well, the last thing the market wanted was to be weaned off of pain medication, despite the fact that the doctor did not actually do any weaning, but merely inferred that said weaning might take place. The stock market plunged, the long term bonds plunged (we have almost no long term bonds, thank goodness), gold plunged. Our take? Complete overreaction. But weird overreaction, not unlike the strange under reaction of the first five months: all bad news – sequester, terrorist attack, North Korea, Cyprus and the market soars. Good (or maybe even just neutral) news, as the economy gets better, the Fed will quit injecting dollars to prop it up and the market tanks.

So what is the reality? All the world's central banks are pumping money at high pressure and volume to get their respective economies moving. That's China, The ECB, the Bank of Japan and the Fed. The dollar numbers are mind boggling: the balance sheets of the Central banks have gone from \$10.4 Trillion in 2007 to \$20.5 trillion today. By my calculations, the balance sheets of the Central Banks are equal to 30% of the world's GDP! So, the question is: if the treatment is working, don't we want it to eventually stop? In other words, if the easing stimulates the economy, then don't we logically want to get off of the QE drip?

Irrational market behavior is nothing new. Our approach is to maintain a cautious allocation and keep our mix properly balanced. We hope the Chairman is right in his view that the economy is continuing to improve. The Sequester has done wonders to the deficit: It's gone from well over \$1 trillion to around \$642 billion. The deficit was 10% of GDP in 2009, and is now rapidly approaching 2%. (Funny how Congress and the President can really work together by doing nothing.) For now, we see continuing slow growth and hopefully a tapering of Fed policy. And, it seems, we need some bad news to stimulate the market...or do we need good news?

retirees could access to help pay for health insurance. The targeted amount would be between \$100-\$130.

**Post 65 Non-Medicare Eligible Retirees** Retirees who worked for the City as of April 1, 1986 and are not eligible to automatically enroll in Part A/B of Medicare, because the City did not participate in Social Security/Medicare, would receive a monthly stipend of between \$200-\$250 from the HRA.

#### RETIREE PENSIONS

The City anticipates having to freeze and restructure the Plan in a manner the City can afford (details not yet provided). (Mostly future retirees); Eliminate future Cost of Living Increases, (no effective date given)

(The full 24 page proposal is posted on our web-site www.rdpffa.com First item on Homepage under Information Emergency Manager Meeting).

In summary, we are just beginning to see some of the specific elements of the Emergency Manager's proposals. As we get more information, we will ask questions and we will continue our analysis. As we get answers, we will pass along the information to all of you.

It appears we may well be in for a long and very expensive legal battle in our attempt to protect the promised benefits we have earned through many years of dedicated service to the City of Detroit. If you are able and plan to make donations to the Association I ask that you specify they be used toward our newly formed legal Fund. I am well aware that, unfortunately once again we will be using the resources that you provide to not only protect your benefits, but also those that choose not to belong to the Association. I am in full agreement with the words and language used by many of you describe those that fail to do their part, but sometimes it is better to not publish those thoughts.


