

Summer has come and gone, and we are still waiting for a decision on our healthcare lawsuit. I know this is beginning to sound like a broken record, but our attorney Chris Legghio says we are very close to having finalized the agreement. As soon as the agreement is released we will notify everyone of the decision.

The mailing, along with the details of the agreement, will include your new membership card. We will also enclose the dues request form for 2009, for those members that are not having their dues deducted from their pension checks.

The court case regarding the 75 million dollars of our pension money has its' first court date set for September 26, in front of Chief Judge William Giovan. The Judge will be hearing arguments regarding the superintending Control portion of the Lawsuit. Briefs regarding this case are due by the end of September.

The active unions have notified our attorney Mike Stefani that they intend to file counter lawsuits against our Association. In which they will claim that we have no grounds for our action against them. We have no intention of backing off our case. As a matter of fact we are looking into the possibility of adding additional charges. Stay tuned, we will keep you posted.

We are moving forward with our efforts to form a state wide retiree organization. We have met with leaders of the Retired State Troopers Association, and have been in contact with representatives of Oakland County Sheriffs, Dearborn and Warren. I also spoke with the President of the newly formed Retired Police

We knew it was coming we just did not know when. Well it happened, the Mayor is gone and I'm sure the structure of the Pension Board is going to change. The seats on the Board including the Chief, City Treasurer, Fire Commissioner, and the Mayor's representative may all be replaced by the new Administration. It will be interesting to see what changes take place and how the newly designated will affect the systems day to day operations.

In my last article I attemped to explain the agreement between the City, Unions and the resolution passed by the Pension Board allowing the City to forgo annual payments of \$25,000,000.00 for (3) years. It seems some members have taken my comments in the wrong way. In the article I tried to explain my personal feelings concerning the active unions attempt to gain benefits for their members. Again I will say that I wish the active unions all the best in negotiating benefits for their members, we all remember the struggles the unions experienced while we worked for the City during contract negotiations. As I attempted to explain, when the agreement the unions and city reach affect monies not being placed in our pension fund, this has a direct impact on our members and our pensions. This is the reason the Association took legal action and we will continue to use any means necessay to protect our rights and safeguard our pensions. I hope this answers any question members may have, if not feel free to give me a call at the office.

There is nothing new on the construction of the new offices for the pension systems. The new site will be the E. Jefferson location and the two (2) systems, General and Police and Fire, are continuing to meet and hammer out the details. With the possible new makeup of the two (2) boards maybe things will move along a little smoother.

In the next few weeks we will see if any changes are made and I will make sure everyone is updated and by the time the next UNITY goes to press more information will be known. Until the next time take care and if you have any problems or questions please give the office a call.



As the weeks and months drift by we seem to be no nearer a solution to the Health Care Case. Retirees continue to pay and pay with no relief in sight. Every time the situation is mentioned the answer is always, have patience the decision is just around the corner. The big question is which corner?

All Retirees are concerned about the final decision and how it will effect their coverage. What choices do they have? When will it become official? All these questions are good ones and must be addressed. Every day this decision is delayed, we the Retiree's, are losing monies from our pension checks. I think that all of us believe that it is the intent to take advantage of the Retirees, no matter what Retired group you may belong to.

I also must inform you that your Association is doing its utmost to finalize this problem. Our Attorney is there, as is our Executive Board. We are, as an Association, doing everything we can do to get a final, favorable decision.

Just recently a new problem has come up in regards to our Health coverage. Some Hospitals, Clinics, etc., have attempted to collect, in advance, a front end deductable when using their facilities.

If you become involved in one of these problems, insist that they call the 1 (800) 951-2583 number on the back of your Blue Cross card.

For those on U.S. Health, or COPS Trust, call 1 (586) 693-4380 or outside Michigan, call 1 (800) 225-9674, to verify your coverage.

Police and Fire coverages do not have a front end deductable clause. Be alert for this!!!

Please remember, your Association membership meetings are as follows - September - east side - October - west side. The location changes from east to west every other month.


