The city of Detroit has now filed for Chapter 9 Municipal Bankruptcy. The trial on the question of the City's eligibility to file for bankruptcy is scheduled to begin on October 23. The rumors are running wild and will continue throughout this process. Your Association will do its best to keep you updated on actual factual matters as we obtain such information and the release of the information is timely and appropriate.

I will start with an update of some of the activities that have taken place.

The RDPFFA is currently using the firm of Lippitt and O'keefe and the Bankruptcy firm of Silverman & Morris to represent the interest of our members. The mediation process is just getting underway and the outcome is unknown. The RDPFFA is doing everything possible in an attempt to maintain our benefits. It has become a daily activity of meeting with our attorneys, attending meetings of the Retiree committee and mediation hearings. This is going to be a very lengthy and expensive struggle. We are going to need all of our members' assistance. We have sent out e-mail request to members to submit letters describing the effects of any reductions in healthcare or pensions would have on their lives. Some of those who submitted letters may be contacted by our attorneys and their information used in Court or in the Media.

We have just been notified (October 11, 2013) that the city of Detroit is moving forward in its' attempt to modify the Healthcare Benefits of retirees effective January 1, 2014. Open enrollment information is being mailed starting today. The RDPFFA opposes any changes to your current benefits and will be taking all appropriate legal action in an attempt to block the implementation of the city's' proposed changes to your healthcare benefits. We will keep you updated on our efforts by e-mail and postings on our web-site and whenever necessary we will notify members of important matters by mail. By the time you receive this issue of the Unity you will most likely had already received your open enrollment booklet from the city of Detroit. At this time about the only thing I can say is you may want to begin looking into the options the city is offering, until you hear from us. We are not endorsing the city plan by any means, but it may take us some time to get a decision from the courts, and the reality is, there is always the possibility that we may not be able to prevent the city from implementing these changes. It is very important that you have an e-mail address with the Association, if you don't have your own give us a family members. You should make regular checks for updates on our web-site. www.rdpffa.com

I know these are very difficult times and there is a lot of uncertainty and things are starting to move very fast. I just want to once again assure you that the Association has both of the Legal Firms we have retained doing everything to stop the actions now underway by the City of Detroit to diminish your benefits. Give us a little time as our attorneys do their work.

There is also a number of other Legal and Professional Firms working on behalf of Detroit Retirees. One is the "Official Retiree Committee".

We all sit and wait, unknown what our status will be in the months and years ahead. Will our pension continue, will we still have health care? These questions still remain unanswered as of today. We know this is frustrating for our members who have questions so all we can do is hang in there and rest assured the Association will get out any information that becomes available.

Moving on to the Federal Government, I would like to update everyone on the "Windfall Elimination Provision" and the "Government Pension Offset". There is proposed legislation in both houses of Congress. On the Senate side there is S.-896 and on the House side there is H.R.-1795, both of these bills would eliminate these provisions which reduce the Social Security Benefits you may be entitled to. I urge all our members to contact their U.S. Senator and Congressional Representative and tell them to support these bills and to sign on as co-sponsors. Explain to them how the situation with the City of Detroit could have on our pensions, health care etc. A simple phone call or e-mail cannot hurt.

Our General Meetings continue and the last two months have shown the concerns we have. We had over 350 in September and more than 275 in October. The Association is attempting to have attorneys who are representing us speak at the meetings and we will try and continue this format. Everyone with computer access can view the information from the meetings and hear what the attorneys have to say, it is quite informative. I would like to bring your attention to the January 2014 which is scheduled for January 2nd. The meeting will be held on this date at the east side location even though it is close to the New Year's Holiday.

The Association is planning on having our June 2014 picnic and meeting in Frankenmuth again. The tentative dates are June 23 & 24, so you can start getting those busy schedules together and make your plans to attend. It was a great time had by all. Once we get the confirmation on the dates the information you need for your reservations will be forwarded to everyone. The annual conference in Las Vegas was again this year a great success. Over 95 of our local and out state members attended. The breakfast was excellent and the conference was very informative. We will begin soon attempting to continue this event will more information to follow. I along with the Board of Directors would like to thank all our sponsors for their continued support for this conference and all our events.

In closing I ask everyone to hang in there during these times, let the attorneys do their job and a few prayers couldn't hurt either. Also the Association will be conducting an election for the three Trustee positions on the Board of Directors, so when the ballot arrives we ask that you cast your vote and return it to the office. The city shall provide for the public peace, health and safety of persons and property within its jurisdictional limits. Public Safety is the number one topic listed in the City of Detroit Charter. As the city prepares to file for Chapter 9 reorganization, like so many who have called the Retired Police and Fire Fighters Association office to voice their concern, I too need to vent!

Public Safety in the City of Detroit has a long history, two proud departments, the Detroit Fire Department who hired its first paid firefighter in 1860 and the Detroit Police Department officially formed in 1861. Through the years, Detroit suffered the loss of hundreds of police and fire personnel who were killed in the line of duty. I along with thousands of others attended the funerals and have heard eulogies how special public safety people are, with a sincere admiration, the vicar would assert how extraordinary and curiously propose a question? What kind of person would risk or lose their life for someone they don't even know? That is Public Service!

Many of our members entered the public safety field after serving the country in the military World War II, Korea, Vietnam and a number of conflicts etc... Some were simply told by family members to apply for a municipal job stating that the pay is not the best but you will have steady work and the likelihood of getting laid off are slim and none. Some just needed a job.

Many of us beginning our career would hear comments echoed by young officers and firefighters how satisfying it was to be on the job and some were upset because they would have to take a day off or reluctance to take furlough time because they did want to miss anything. Some, innocently and privately saying (although "in jest"), that they loved the job and would work for nothing because they enjoyed it so much! That was the atmosphere in the departments among the personnel.

The above paints a picture of a satisfied worker and working conditions although I am not naive that this rosy picture was not had by all. Those who came on the job in

the late forties knew the pay was low but had to pay for their own uniforms, work six days a week and had no benefits. The Firemen's Fund and the Police Benefit and Protective were organized for one reason, benefit plans to assist families of Police and Fire people who died in the line of duty because there were no funds provided by the city to assist the family following a tragedy.

The city grew and times were prospering, conditions were improving and benefits were negotiated between organized labor unions and the city. Elected representatives were given the responsibility to negotiate contracts that were agreed to by both sides, the employer and the employee. The constant failure to negotiate a mutually agreed contract relying on Act 312 awards was disconcerting. Most recognized that something was wrong; in all probability the city was not accurately reporting their financial situation.

Now reality, the cities desire is to file for Chapter 9 bankruptcy reorganization. Special teams from Washington enter the picture, they formerly present a process that must be followed; On 8-2-13, the Honorable Steven W. Rhodes directs the United States Trustee to appoint an Official Committee of Retired Employees to represent the interests and act on behalf of all retired employees of the City of Detroit. A request was made to the RDPFFA to submit names to interview and serve on an official committee of retirees. The association presented names of qualified members that came forward willing help. On 8-20-13 an U.S. Trustee presents the guidelines to about 100 in attendance. The Trustee states that the committee will be filled with 7-9 applicants; it will represent all retirees to develop a plan with collective views adequately represented with diversity. As I sat in the room and listen, I thought to myself that this whole charade was a scam! I believe it was a done deal - what an insult!

Now we have an appointed committee of 9 who meet regularly. Unfortunately retirees are considered creditors under bankruptcy laws and are a prime target. The law that compares us to bond holders who invested in the city, whose skin in the game is money, is wrong. Retirees negotiated contracts should take priority and be honored. Our skin in the game is our livelihood and unfortunately for some their "life". The reorganization of city government needs to be done, however nothing should be taken from retirees who fulfilled their part of the agreement and are vested. It's a disgrace, who would of thought after years of service, that were only faceless numbers – What a shame!

Due to the very large number of letters received by the association in response to the current circumstances with the City of Detroit, we will not be publishing the members letters in this issue of the Unity.

# **RDPFFA 2014 Election Rules**

Only Active Members are eligible to run for office, Associate Members are not eligible to run, or vote in elections. Candidates are not eligible to run for more than one elected position within the Association, Candidates may be nominated for any number of positions, but may, only accept and run for one position.

Nominations for offices will open on September 1, 2013 and will close on October 3, 2013, at the General Membership Meeting. Candidates for office may have their names entered into nomination during the nomination period at the RDPFFA office or at the September or October 2013 General Membership meetings.

The Chairman/Representative of the Election Committee will take Nominations from the floor at the September and October General Meetings. At the October General Meeting the Election Committee Chairman/Representative will close the nominations for all offices. For a Candidate to have his/her name appear on the election ballot, he/she must accept the nomination in writing within 14 days of being nominated.

Following the close of the acceptance period, the Election Committee will cause the election ballot to be prepared, and insure that all Candidates listed have accepted the nomination, and that all Candidates are current Active Members of the Association. If only one Candidate has been nominated for an office and has accepted the nomination, then the Candidate will be considered elected, and no election shall take place for that position.

Ballots will be mailed to all currently listed active members on November 1st, 2013; along with the ballot a specially printed return envelope will be included. In order for a ballot to count it must be returned to the RDPF-FA office by November 21st, 2013, and must be returned in the specially designated return envelope. As election return envelopes are received at the RDPFFA office, the envelopes will be counted, remain sealed and placed in a lock box designed for such purpose by the Election Committee.

Voided ballots will be kept separately; the Election Committee will count and tally the ballots prior to the December General Membership Meeting. During the ballot count observers will be allowed as well as candidates or their designated representative. It shall be the duty of the Election Committee Chairman to provide instructions and appoint personnel to count ballots.

The Committee at their discretion may recount any or all ballots cast. Any candidates may request the Committee to conduct a recount in any disputed position for which they were candidates within 7 calendar days of the December General Meeting. The request to the Election Chairman must be in writing and signed by the candidate making the request. Recount requests shall not be honored by the Committee if their total count for any office being contested shall show an identical count total for two consecutive tallies. All election results will be announced prior to the end of the December General Membership meeting. All ballots will be maintained at the RDPFFA office for a minimum of 60 days following the election.





This committee was approved and authorized by the Bankruptcy Court. The members of the committee were selected by the United States Trustees Office. I am serving as one of the members of the committee, list of other members is posted on our web-site. Once the formation of the committee was completed and approved by the Court, the committee was authorized to retain professionals to represent retiree's interest in the bankruptcy proceedings. The firms retained by the Retiree Committee are as follows:

The Lead Counsel is the Firm of Dentons; they will be working with the local Bankruptcy Firm of Brooks Wilkins Sharkey & Turco. The Financial Advisers is the Firm of Lazard Freres & Co (Lazard). The Actuary Advisers is the Firm of Segal Consulting. These are all large nationally renowned firms with years of experience in area of Bankruptcy and restructuring.

The following factual information has been provided to the RDPFFA by the firm of Dentons, the Legal Professionals representing the Official Committee of Retirees in the Detroit Bankruptcy.

# DETROIT'S BANKRUPTCY-AN UPDATE FROM THE TRENCHES

### The City's Proposal To Retirees

The City of Detroit's initial proposal to 20,000 retirees and their beneficiaries is simple. The City intends to stop making contributions to the General Retirement System and the Police and Fire Retirement System on account of the retired employees. Instead of contributions, the City intends to give retirees an **unsecured claim** for the unfunded actuarial liability, which Milliman, the City's actuary, estimates to be approximately \$3.5 billion and

leave the retirees with the existing assets in the pension plans and the claim to pay benefits.

The retirees' unsecured claim will be only part of a total pool of unsecured claims estimated at approximately \$11.5 billion. To pay all of these claims the City intends to issue a \$2 Billion Limited Recourse Participation Note. Based on these numbers, the retirees' share of the \$2 Billion Limited Recourse Participation Note, proposed by the City to satisfy all unsecured claims, is approximately \$667 million.

The Limited Recourse Participation Note, however, is an interest only Note, payable at 1 ½% interest. Principal **may be, but need not be,** repaid if certain conditions are met. Based on its terms, the value of the Note to the retirees may be as little as \$9 million a year. At the rate of current benefits and with the minimal amount of value contributed by the proposed Note, the assets of the pension funds will run out in 8 to 10 years and the retirees' pensions will be completely gone.

No other City has treated its obligations to retirees as general unsecured claims. Most municipalities in Chapter 9 have left or will leave the retirees pensions intact. The City of Vallejo assumed pension contracts with CALPERS under its plan and its health claims were paid in full. The pension plans passed through unimpaired in the Jefferson County and Orange County bankruptcy cases and will pass through unimpaired in the Stockton bankruptcy. Even the Central Falls plan, which impaired some pension rights, provided in full for certain levels of benefits, including accidental disability retirement claims.

The City's plan violates Article 9, Section 24 of the Michigan Constitution. This Constitutional provision prohibits the impairment or diminution of accrued pension compensation AND makes funding of pension plans on an annual basis an absolute requirement. Nevertheless, the initial plan proposed by the Emergency Manager and the City places no value on this Michigan Constitutional mandate.

As a practical matter, the City's approach to retiree pensions and the proposed defined contribution replacement plans will negatively impact the City's ability to retain qualified individuals in the public sector. Plan closures also raise employee administrative costs substantially in the short term.

### THE CITY'S TACTICS

In order to deflect attention from its plan to stop funding retiree pension benefits and to dramatically

reduce health benefits, the City is placing blame for the alleged shortfall in the pension plans on the Retirement Systems and the retirees themselves.

The City filed the Declaration of Charles Moore, a restructuring professional, not a pension expert, with its bankruptcy petition. In the declaration, Moore casts aspersions on the Retirement Systems' practice of smoothing instead of using the market value of assets in their valuation. Yet, the City's pension expert, Milliman Inc., testified under oath that smoothing is a standard actuarial practice to avoid radical changes in contribution rates caused by fluctuations in the market value of plan assets.

Moore also attacked the rate of return assumption used by the General Retirement System (7.9%) and the Police and Fire Retirement System (8%). The Retirement System is not out of line with the expected investment returns for large public pension plans. The Michigan Public Schools Plan, the State Employees' Pension Plan and Michigan MERS all assume an 8% investment return, for example.

Finally, the City's pension expert, Milliman Inc., testified that it has not evaluated the actuarial data of the Retirement Systems, but rather used the assumptions provided by the Emergency Manager.

# THE CITY CAN AFFORD TO TAKE CARE OF ITS RETIREES

The City claims that termination of its pension plans is a financial necessity. But the City can afford to take care of its retirees without sacrificing reinvestment initiatives for the City's redevelopment.

In support of its proposal, the City offers a ten year forecast. The forecast focuses solely on the general fund and deliberately leaves out cash flow and contributions from other sources, including the Department of Water and Sewer, which contributes to the GRS directly and nearly 1800 employees. The City's own projections show \$50 million of additional free cash flow after the 5th year when the reinvestment program from the general fund is complete.

The City has also not factored in asset monetization, tax collection, and federal and state support for its recovery.

The average pension of retirees in the Police and Fire Retirement System is approximately \$32,000 a year. And as you know, many of the uniformed retirees are not eligible for social security benefits and those

hired before 1986 are not eligible for Medicare.

The City can and must do better to honor its obligations to its retirees. Retirees need to show a united front combatting the City's proposal and its negative press campaign.

### Back to my article...

The professional firms retained by the Official Retiree Committee is utilizing the services of a public relations and media firm, and is now releasing information to the media in an attempt to counter the negative press and unreliable information being put out by the City.


