# PRESIDENT Don Taylor

The Bankruptcy confirmation trial is finally over, and Judge Rhodes has indicated he will release his decision on November 7th. If approved it is expected that the Plan of Adjustment would become effective around the first of December. What does this mean to us? I will attempt to summarize the terms of our settlement.

#### **Pensions**

Police & Fire Retirees will not see any reduction in their current pensions.

They will continue to receive annual COLA increases at rate of 45% of previous amount, approximately 1% annual increase. (These annual increases are permanent and not effected by the restoration policy). Old plan members will continue to receive increases based on pay and increases of actives, at the rate of 45% of what they would normally receive. (Old plan members will start seeing annual increases under the terms of the actives settlement starting July 1, 2016 maybe earlier.) Scheduled wage increases DPOA 8% immediately, 2.5% each July 1, of 2016, 2017, 2018, question remains regarding what effect on retirees under the old plan the 10% wage cut taken by actives will have.

Restoration of COLA will be based on annual returns and funding levels of the P&F retirement system. Currently the value of these returns have made it possible that the next step in restoration may already be or is very close to being due.

Current retirees, those retired as of June 30, 2014, will have their COLA restored to a value of 66% prior to new retirees or actives receiving COLA restoration.

COLA that has been restored will become permanent after June 30, 2023, if the pension fund level of the Police & Fire Retirement system is 78% or higher.

There will continue to be two elected retirees serving on the Pension Board, one retired police and one retired fire.

There will be a special election for these two positions as soon as practicable after the Plan of Adjustment is confirmed.

The Two elected retirees will also be appointed to the Investment Committee, this is the pension oversight committee required by State and Grand Bargain settlement.

#### Healthcare

Police and Fire Retirees will have a separate Healthcare VEBA

The VEBAs are funded by a B-Note, the amount was set at 450 million, with the VEBAs receiving additional amounts under a settlement with Syncora and FGIC/COPS, and this additional amount is 42.68 million. Under the Plan of Adjustment the B-Note is allocated with the Police and Fire VEBA receiving .516%. The P&F VEBA should receive approximately 254 Million. (Because the RDPFFA was able to split the VEBA giving P&F their own VEBA the value of Weiler Settlement agreement was taken into account)

The composition of the Board of Trustees of the P&F VEBA will be of 7 Voting members, one non-voting member. The voting members initially will be appointed as followed; 1 by the Mayor, 3 by the Official Committee of Retirees, and 3 by the RDPFFA. After the initial appointment the RDPFFA will appoint all voting positions except the one appointed by the

Well it looks like we will see the light at the end of the tunnel very soon. The bankruptcy trial is over and a decision will be made on November 7, 2014 with a written ruling soon to follow. All the legal experts expect the Plan of Adjustment (POA) to be approved and allow the City to emerge from bankruptcy. Now it will be up to the City, its leaders and all the overseers to make sure this will not happen again. This has been a long, frustrating and expensive process but it appears we will come out of this process better than what was originally forecast.

Health care is another subject that has everyone concerned. Through the bankruptcy process and mediations it was agreed upon that the City will extend the present so called healthcare benefits through the 2015 calendar year. This will include the presents plans offered the Medicare eligible retirees and the stipends

for those not eligible for Medicare. You will or may have already received the open enrollment packet from the City. We understand that it will be mailed very shortly. This will be the final booklet you will receive from the City and we ask that everyone review the packet very carefully and make any changes you feel you need at this time. Keep an eye on the dates listed in the booklet as it appears it will be a short time frame for any changes to be made. As we understand any changes will be completed by phone or on line only, there will be no paper forms to be completed. If you are going to keep the present plan you have you should not have to do anything although if you are going to make changes or opt out of the City plan and get you own plan or get your coverage from your spouse or through another employer this is the time to do that. Follow the instructions carefully and again watch the dates. For those non Medicare eligible retirees your stipends will continue as is until March 31, 2015. Beginning in April 2015 retirees will have the option to receive not-taxable benefit to help pay for medical coverage. Options will be provided to ensure that retirees can continue to be eligible for premium assistance they receive to pay for Marketplace Coverage (Obama Care). This is also the time to enroll in or make changes to any dental or vision benefits being offered that you may be interested in or would like to drop. COPS Trust is also going to have an open enrollment for the Delta Dental Plan they offer and an additional vision plan, this should also be in the mail shortly. If you are presently enrolled in the Delta Dental Plan it will continue without you having to do anything and you will not receive the packet. All premiums will remain the same for 2015. So please read over all the materials very carefully and pay attention to the dates for any changes you make.

With 2014 winding down quickly the Association would like to thank all our members for there generous

Detroit's problems have been building for some time. It's lost a quarter of its population in the last decade. A city that grew to 1.8 million people in the 1950s ranked as the 5th largest city in the United States has spiraled down ever since. Detroit's population in 2000 was 951,270, which dropped to only 713,777 by 2010. In 2013, the city's estimated population is 688,701. In 2012, out of the top 50 U.S cities Detroit is ranked 18.

By 2009, the auto industry collapsed along with the economy as a whole, eventually pulling the city down

with it. Government corruption under former mayor Kwame Kilpatrick only made things worse.

The city of Detroit couldn't pay its bills, and so, on July 18, 2013, it declared bankruptcy under Chapter 9 of the federal Bankruptcy Code, the chapter reserved for municipalities. Detroit estimated that it had \$18 billion of debt—about \$12 billion of unsecured debt and \$6 billion of secured debt—and 100,000 creditors. Almost all of the unsecured debt is related to health and life insurance and unfunded pension obligations.

In bankruptcy CBA's (Contract bargaining agreement) are not binding. The Cities administrators' misguided direction and poor decisions lead to numerous casualties and consequences, one loss for retirees is a promise that the city could not keep and that is our Health Care benefit.

Now in bankruptcy, the professionals enter the picture and are projected to spend \$182 million to deal with the legal and financial issues cautiously being fair, equal and just too all creditors. "What a Fiasco"!

Mayor. The non-voting position is appointed by the Retied Detroit Police Members Association (RDPMA); this position will terminate on December 31, 2018.

The VEBA Trustees will be responsible for setting benefits for retirees Healthcare. The current plans are expected to remain in effect until April 1, 2015 and maybe beyond. So please allow some time for the Trustees to get into position and establish policy and benefit levels. I am sure you will be hearing from the Trustees once/if the Plan of Adjustment is approved by Judge Rhodes.

On the POA effective date the Employees Death Benefit will be frozen (the life insurance .9 cent Plan). The City will have no obligation to fund the Plan, Retirees will be given one time option to receive payout, or they can remain in the Plan. It will take time for the city to calculate payments.

This is just a short summery of the settlement agreement of the RDPFFA under the Plan of Adjustment. As we have pointed out throughout this process, no one wins in Bankruptcy. I believe if you read the POA and our settlement agreement you will see we were able to come out somewhat better then others. In the pension area the RDPFFA was able to negotiate no reductions in current pensions and maintain a portion of the COLA. Our settlement agreement was 3% more in value on pensions then another group representing retirees was going to use as a starting point. In our Healthcare settlement we were able to split the VEBA into two parts giving the P&F a larger portion of the B-Note, approximately 16 million dollars more to fund the P&F VEBA. After the initial appointments to the VEBAs the RDPF-FA will control 6 of the 7 seats. There will be two elected retirees on the Pension Board and the Investment Committee, which oversees the investments of the Pension Board.

There will always be those that disagree with any outcome, but I believe this was the best possible outcome under the circumstances we were faced with. Only pensions had a chance of being protected in Bankruptcy under the State Constitution, and not all of our attorneys were in agreement as far as protection of annual increases COLA (which is all P&F loss) and I spoke with a number of attorneys including the State Attorney General that agreed to reverse any reductions in the Courts may require two trips to the US Supreme court. If successful the first time, it was liking the city would not have funds and point at the State

Constitution, requiring a second suit against the State to enforce the Constitution and require the State of Michigan to fund pensions. This would have resulted in a very long and costly legal fight. Facing the possibility of millions of dollars in legal fees, and a lengthy court battle that may not end under the lifetime of many of our members, and an uncertain outcome of the legal challenge, we made the decision to seek a settlement.

This settlement did not come without cost. The RDPFFA has spent over \$600,000 in this legal challenge, but as pointed out in this article I believe we were able to provide benefits at a much greater level then would have been achieved otherwise. The generosity of our members has resulted in over \$247,000 in donations to the Legal Fund. Many of our members are making regular donations to the Legal Fund in varying amounts from as high as \$1,500 dollars to \$10 dollars per month. In the letters included with these donations many include notes that they would like to donate more put just don't have the resources available to do so. It is gratifying to see so many members step up to assist the Association in the effort to fund this legal battle. We fully realize that there are many that are just getting by and cannot afford any additional expenses at this time. The Association is not by any means facing the possibility of defaulting on its financial obligations, but I believe we do need to maintain the funds necessary to meet any future challenge we may face. So even though the Bankruptcy in coming to an end, we continue to need the support from those that do have the ability to assist in replacing our depleted reserves.

In closing as we finally near the end of one of the most challenging events in our lifetimes, I want to express my sincere appreciation for all those that have expressed words of appreciation and encouragement throughout this process. I have also heard from a few of those self-educated bankruptcy experts that with very little if any real facts or knowledge of the circumstances, have criticized the efforts of the Association at every step. I can ensure you that prior to making a recommendation to the Board of Directors to consider entering into the settlement agreement I reviewed thousands of pages of financial documents, attended hundreds of meetings and spoke with many experts that did have the knowledge and expertise in the fields necessary to assist me in making an informed decision. Again this was Bankruptcy, with limited options, none good.

Thank you for your support, and hope to see you at the Association meetings and events.







# Medical Expenses for Detroit Retirees: New Things to Know

Many components of financial planning relate to investments, taxes, or estate planning. Here are some ways to protect your family and assets that don't take up too much time or money, but will give you piece of mind.

List your valuable papers and put them in a safe place. Do you have your house insured? Good. Do you keep the insurance policy in your house? Bad. Things like your insurance policies, tax receipts, wills, deeds, military record and other valuable papers should be listed, so someone knows where they are, and put in a safe place. By 'safe' I literally mean a safe, like a safe deposit box or a fireproof safe. Don't have one? Use your freezer. Put your papers in a one gallon ziploc bag and put them in the freezer. The freezer will last about an hour in a house fire. Also, tell someone where the papers are, just in case you're in the house.

**List your PIN numbers.** In today's world, we all have a 'digital legacy' of passwords, emails, PayPal's, EBay's and so forth. Make a list of your online accounts and passwords. Encrypt it and put it in a safe place. As usual, tell someone you trust how to find the list.

**Protect your wallet.** Think about what happens if your wallet is lost or stolen. Take out your smart phone or find a copy machine. Make a picture of the contents of your wallet, including the health card and the credit cards. Protect the photo with a password and save it. Make sure someone you trust also has access to it.

Make an inventory of your house contents. I've had a fire and a tornado in the last 8 months, so now I'm spooked. Take your smartphone, iPad, or digital camera and go through your house taking photos of everything. Put something in the picture, like the most current issue of Time magazine, to identify the date of the photo. Download the pictures to a safe file and keep in your safe place. If the house is burgled or destroyed, you have a record of the contents. While you're at it, if the contents are valuable, get replacement cost coverage on your homeowner's policy.

Use auto bill pay. Who likes to pay bills? Not me. Not only is paying a bill a pain, but I have to buy stamps, envelopes, write the checks and make sure it's done on time. Banks and Credit Unions offer auto-bill pay services that will automatically pay your regular bills. Most of us use automatic deposits (which make sense); why not use automatic payments. Be sure to record your auto-pays in your checkbook. Is it safe? Yes. In fact, auto pay removes the possibility of loss or interceptions of the check. Just be sure to monitor the accounts.




